Despite the recession that required us to cut \$62 million or 22% from the budget over the last 6 years, we have accomplished so much!



I am honored to have served Leon County and District 5 since 2010 and remain committed to an efficient, effective and collaborative County government. While the work of the Commission is dynamic and keeps us busy, I also serve on numerous Boards that provide essential services to our community.

I just concluded 3 years as Chair of the Leon County Research and Development Authority, which manages Innovation Park. The organization faced many challenges when I joined the Board, but I am energized by the progress we've made. We will invest in new development at Innovation Park and continue to support economic development through a renewed focus of research and start-ups that can, and will create new jobs. LCRDA will be announcing new initiatives early in 2016, so stay tuned!

This year I also served as Chair of the Capital Region Transportation Planning Agency, where we made progress towards streamlining transportation planning to help maximize the dollars we bring to our community from our state and federal partners.

I also served as Chair for our regions newly-created Continuum of Care Board, which coordinates efforts to help our homeless neighbors in 8 counties. The CoC has gotten off to a great start to address the important issues related to homelessness throughout our region.

The last 5 years have been busy, but my love for Leon County and our dedicated and passionate citizens has never been stronger. I look forward to another great year and I wish you all the best throughout the holidays and for a great 2016!

## Domi Annual Report

In October 2013, Leon County entered in to a public-private partnership with Domi Education, Inc., to operate an urban business incubator program in a County-owned warehouse. In May 2014, Domi Station held its grand opening and since has worked with new businesses to generate \$2.9 million in revenue, hosted/organized more than 175 events and create more than 30 full-time jobs. The total number of companies with membership to Domi increased to 94 with 38 of these member companies being housed in Domi Station.



Domi helps entrepreneurs develop their companies through mentorship and business support resources. The development of the Domi incubator is a result of Leon County's support of entrepreneurs, and a vision to transform a former warehouse into the urban business incubator to become a catalyst for idea exchange.


