Highlights of Today's County Commission Meeting

2017 County Budget:

This will be the last Commission meeting before our summer break and we will reconvene on September 13th for the first of two public hearings on the 2017 budget. Having completed much of our work, we canceled today's budget workshop, but there is still time to ask questions and make comments before we finalize our budget at our September 20th meeting.

Southwood:

Recently, we have received calls and emails from the Southwood neighborhood about increased crime in the area. At today's meeting, the Commission will authorize the Community Development District (CDD) to exercise their power to increase security in the unincorporated portion of the neighborhood. The City Commission has a similar item on its agenda for July 13th for those areas inside the city limits. We hope that this action in partnership with local law enforcement will help address recent issues in Southwood.

Leon County Energy Improvement District:

In 2010 the County Commission adopted an ordinance creating the Energy Improvement District and a local Property Assessed Clean Energy (PACE) Program for residential property. In 2012 the program was expanded to include commercial property.

Leon County has taken a leadership role nationally and has successfully helped resolve issues with the State and Federal government.

The PACE program will offer grants and loans for residential property and low interest loans for commercial property to improve the energy effect and resiliency, which will not only save property owners money and provide work for local contractors, but will also help us reduce our carbon footprint.

The PACE program, in partnership with the private sector, will launch this fall and we will share more information and training opportunities for contractors and Realtors as it becomes available.

Leon County Commissioner becomes President of National Association of Counties (NACo):

On July 25th in Los Angeles, our very own Commissioner Bryan Desloge will be sworn in as the President of the National Association of Counties.

Bryan has been working hard on behalf of Leon County and the more than 3000 counties nationwide as part of NACo's leadership team. Commissioner Desloge's term as President will not only provide a steady and collaborative voice for counties nationwide, but will allow us to highlight the great work and results we've seen in Leon County.

We are also excited to host the NACo Board of Directors meeting and Rural Action Caucus in December. This meeting will bring hundreds of elected leaders and staff from across the country to our community, contributing to our local economy and allowing us to highlight our many assets.

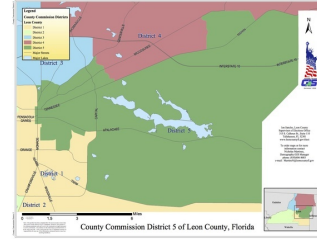
