Next Tuesday, the Commission will hold the first of two public hearings on the proposed 2018-19 County Budget. The Commission tentatively approved the proposed balanced budget back in July without raising the millage rate for the seventh year in a row. The \$262.5 million budget is an increase of 3.4% over last years budget and accounts for an increase in property values of 5.6% countywide.

The hearing will be held on **Tuesday, September 4** at 6:00 pm in County Commission Chambers located on the 5th Floor of the County Courthouse (301 N. Monroe St.). The public hearing is open to all residents and it's an opportunity for us to hear from you.

National Championship Team**

At next Tuesday's Commission meeting I will have the honor to lead the recognition for the FSU Women's Softball Team for winning the 2018 Women's College World Series.

Coach Lonni Alameda, along with members of the team will join the County Commission as I present them with a Proclamation celebrating their historic win in the NCAA Tournament earlier this summer in Oklahoma City.

This win marked FSU's first National Championship in its first appearance in the Women's College World Series Finals, and the first title for the Atlantic Coast Conference.

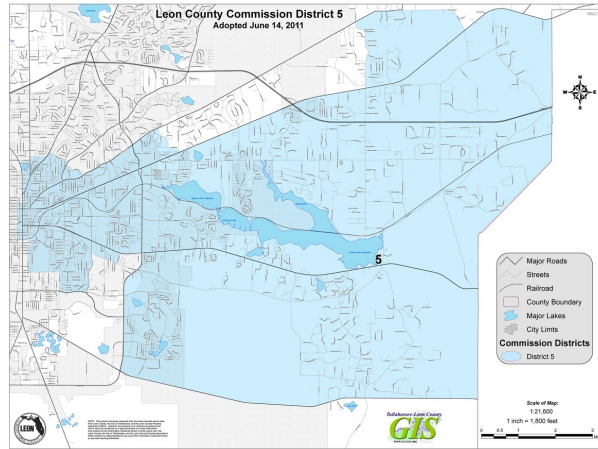
