Storm Debris Pickup

Storm-related debris collection began this week and will continue until all storm-related debris is picked up. As you begin your cleanup, please remember the following tips:

- All debris should be placed curbside between the sidewalk or property line and the curb
- Debris should be separated at the curb from vegetative, construction and demolition, appliances and white goods, electronics, and household hazardous waste
- Debris removal trucks will not pick up household garbage; Waste Pro will continue to collect trash and recycling

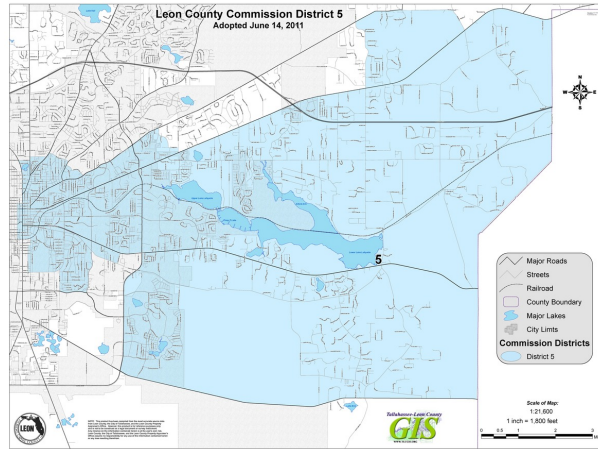
