The City's Planning Continues for Northwood Parcel -- Next Community Meeting on March 29



Planning continues for the future of the Northwood parcel, which - although a City project - is right in the heart of County Commission District 3.

As a follow-up to the project's January community meeting (see video above), the City of Tallahassee will hold another community meeting on **March 29** to provide a project update and share feedback gathered to date. The meeting will be held at the **Tallahassee Senior Center (1400 North Monroe Street) from 6-7:30 p.m.**

More than 200 residents attended the meeting in January, and many more have submitted comments via email and the online survey. This feedback is being used to guide long-term master planning efforts for the area. Continued community participation will ensure redevelopment evolves to best serve residents.

Following the March 29 meeting, a feedback form and recording of the project update will be available on the project website, <u>Talgov.com/NorthwoodProject</u>. For those unable to attend, feedback can be emailed to <u>NorthwoodProject@Talgov.com</u>.

Recognizing the opportunity to reinvigorate this once-vibrant site, the City Commission approved the City to participate in the property's auction. As a result, the 29.5-acre parcel was purchased in April 2019. At the time of purchase, the City was in the middle of the site selection process for the future headquarters facility for the Tallahassee Police Department. Through that process, the Northwood Centre location was recommended by technical experts and the majority of the public who attended community meetings and provided input due to its central location, accessibility and size, and it was ultimately selected unanimously by the Commission.



You Can Help Reduce Human Trafficking in Our Community




Survive and Thrive Advocacy Center (STAC) recently released <u>STACPRO</u> - Leon County's first and only comprehensive virtual human trafficking training program. Best of all - it's FREE, takes less than an hour to complete, and is open to all.

Be among the first to take this training and do your part to make our community a safer place. This training applies to workplaces of all kinds including hotels, restaurants, shops, convenience stores, offices, financial institutions and more. In just under an hour, you'll learn how to recognize and respond to suspected human trafficking happening here in Leon County, and you'll receive a downloadable certificate acknowledging your completion of the course.

We can all play a vital role in identifying trafficking acts or victims. With the community's support, we're building a network of people and organizations who stand with survivors and work together to prevent human trafficking.

Update on the Thomasville Road Multi-Use Path



As mentioned in the last newsletter, last week the Capital Regional Transportation Agency - of which Rick is a member - was asked to allocate design funds to the Florida Department of Transportation (FDOT) for the Thomasville Road Multi-Use Path.

When the Feasibility Study for the path was approved by the CRTPA members recently, Rick objected to its passage; and last week, **Rick was the only vote against moving forward with the design phase.**

So what are the next steps? FDOT will now take over the project and begin design. Although he opposed the multi-use path along such a busy road, Rick is hoping to work with FDOT and any interested citizens to ensure that the design will be safe, user-friendly and minimize the loss of trees. Going forward, there will be more opportunities for the public to review and comment on FDOT's design proposals and our office will stay on top of this project. Please stay tuned.

Help for Low-Income Households Get Access to the Internet

Stay Connected

The Affordable Connectivity Program (ACP) helps low-income households pay for broadband service and internet connected devices.



The Affordable Connectivity Program (ACP) is a <u>Federal Communications Commission</u> (FCC) program that helps low-income households pay for internet service and connected devices.

If your household is <u>eligible</u>, you can receive:

- Up to a \$30/month discount on your internet service
- Up to a \$75/month discount if your household is on qualifying Tribal lands
- A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a co-payment of more than \$10 but less than \$50)

Only one monthly service discount and one device discount is allowed per household. To receive the connected device discount, consumers need to enroll in the ACP with a <u>participating provider that offers connected devices</u> (Note: not all internet company offer device discounts.) The internet company will provide the discount to the consumer.

Leon Works: Earn a Paycheck While Gaining Hands-on Experience in a Skilled Career Field



The Leon Works Junior Apprenticeship Program is an opportunity for Leon County high

school juniors/seniors to prepare for a skilled career – those jobs requiring more than a high school diploma, but less than a four-year degree.

By the year 2025, over 68,000 skilled jobs will be available in the Leon County area. To prepare students to fill these jobs, Leon County Government is partnering with CareerSource Capital Region and Leon County Schools to provide students with job readiness training and work experience!

For one semester, selected students will work in a Leon County department as a Junior Apprentice shadowing and assisting a County staff member in a skilled career field that the student is interested in pursuing. Junior Apprentices will also complete CareerSource Capital Region's Dynamic Futures training to prepare them for entering the workforce after graduation. In addition to gaining valuable work experience and training, Junior Apprentices earn an hourly salary and elective credit toward their high school diploma.

Youth between the ages of 14 and 24 can apply now for summer employment

Leon County Government is now accepting applications for the Summer Youth Training Program. In partnership with CareerSource Capital Region, the Summer Youth Training Program is a five-week program in which youth gain job experience by working with a Leon County department over the summer.

Youth can apply for positions across various County departments including an internship with Commissioner Minor. Other departments include Community and Media Relations, Volunteer Services, Emergency Medical Services, Library Services and more. All positions are 20 hours per week and pay \$10 per hour. Summer employment and training will run from Monday, June 27 through Friday, July 29, 2022.

Leon County and CareerSource Capital Region's partnership gives youth more professional development opportunities through Dynamic Futures, a training program for young adults. CareerSource Capital Region will help youth learn important skills such as goal-setting, budgeting, time management, customer service and so much more.




