#### **Updates on WastePro**



A number of you have reached out to our office with concerns about Waste Pro. Accordingly, we wanted to provide this update, from the July Board of County Commissioners Meeting Agenda:

- Culminating in June, Waste Pro experienced a reduction in service delivery to
  unacceptable levels. Most notably this reduction has impacted collection of yard
  debris, with some areas not receiving service for several weeks. Numerous garbage
  and recycling routes also were incomplete. Staff remained in near constant contact
  with Waste Pro leadership in the field and met with impacted residents to validate
  complaints and ensure citizens receive the service they pay for.
- Waste Pro acknowledged the broader sentiment of operations not being acceptable
  in preceding months. Indeed, there have been recent changes in management in
  light of needed improvements. New interim leadership has made numerous
  corrective actions to improve staffing, equipment, and service response. To ensure
  all routes are caught up, additional trucks have been added to service yard debris
  and Waste Pro is running an extra day (Saturdays) until further notice. It is expected
  that all customers will receive service as required by the Agreement.
- Waste collection in general has been facing challenges: a combination of COVID, hiring and retention troubles, supply chain interruptions, and equipment failures.
- WastePro's efforts to correct the decline in service include:
  - New management continues to make numerous process improvements focusing on internal and external service delivery.
  - Wages have been increased 30% for field staff;
  - Waste Pro supervisors are temporarily driving service trucks and weekends are being worked to complete routes;
  - Using large trailers in conjunction with collection trucks, to increase efficiency of collection.

At the Commission meeting, Rick stated that he had heard from people in our District about yard debris sitting for months and missed pick up.

"It's a problem. This is unacceptable," he said. "As far as I'm concerned, Waste Pro is on notice. If they do not have an improvement, we're going to have a serious discussion about the contracts going forward."

In July 2020, the Federal Communications Commission (FCC) designated 988 as the new three-digit number for the National Suicide Prevention Lifeline (1-800-273-TALK).

988 is an easy-to-remember number that will not replace any of the functions of 911 or 211 but will focus on providing immediate support for those in emotional distress or suicide crisis.

211 Big Bend has been a National Suicide Prevention Lifeline partner for many years by responding to these calls for 14 counties in Northwest Florida. 211 Big Bend will continue to answer suicide and mental health crisis calls as 988 expands. 211 crisis counselors are trained to assist people in emotional distress or suicide crisis, regardless of whether they call 988 or 211. In addition to mental health crisis, 211 provides support for finding community resources, such as food pantries and basic needs assistance, as well as care coordination services.

Call for Volunteer Committee Members: Board of Adjustment and Appeals



The Board of Adjustment and Appeals (BOAA) currently has an opening for a committee member, as well as an alternative committee member.

The responsibility of the BOAA is to conduct hearings on appeals and variances for the City of Tallahassee and Leon County. BOAA members are required to review the staff reports on the requested appeals and variances cases, conduct hearings in order to make findings of fact and, with the assistance of the BOAA attorney, make conclusions of law to make a determination on the requested appeal or variance. The Board acts on appeals and variance applications in accordance with criteria set out in the city and county codes for such reviews.


The BOAA is supported with staff of the Leon County Department of Development Support and Environmental Management and the City of Tallahassee's Growth Management Department. The BOAA receives legal advice from its own attorney.

Per the BOAA bylaws, to be eligible for appointment, members must be a resident of Leon County, an owner of real property, and a taxpayer. In addition, any person selected for the BOAA is expected to attend all meetings.

Members must file a Financial Disclosure Form 1 from the Florida Commission on Ethics within 30 days of being appointed and annually by July 1 thereafter. In addition, when leaving, the committee members must file a final Form 1F within 60 days of leaving their public position. The final Form 1F covers the disclosure period between January 1 and your last day of office within that year.

### Leon County Wins Bid to Host World Cross Country Championships in 2026 at Apalachee Regional Park



World Athletics recently announced that Leon County has been awarded the 2026 World Athletics Cross Country Championships at the award-winning Apalachee Regional Park!

As the *most prestigious competition in international cross country running*, this event marks the first world championship sporting event ever to be held in Tallahassee/Leon County.

Held since 1973 in cities across the globe, including Paris, Rome, Denmark and others, the World Athletics Cross Country Championships has only been held in the U.S. twice: East Rutherford, New Jersey, in 1984 and Boston, Massachusetts, in 1992.

The World Athletics Cross Country Championship is expected to draw more than 550 runners from over 60 countries that will compete in five official World championship races at Apalachee Regional Park. While it will be internationally broadcast, the event is projected to be attended by 10,000 spectators from around the world, bringing in an estimated economic impact of over \$4.3 million!

# Leon County Accepting Tourism Grant Applications for Signature, Special & Sports Events



In its ongoing efforts to promote tourism and financially support events that have a history of or show potential to attract out-of-town visitors to the area, the Leon County Division of Tourism (Visit Tallahassee) grant application process for the 2022-23 Signature/Emerging Signature, Special and Sports Events Grant is now open and accepting applications through Aug. 12, 2022.

Eligible event(s) must take place between Oct. 1, 2022, and Sept. 30, 2023, and are required to comply with Section 125.0104, *Florida Statutes* for the utilization of Tourist Development Tax funds. Event grant applications are evaluated based on the potential to draw overnight visitors, interest to the general public, the ability to demonstrate out of area marketing activities, scheduled programming/activities with visitor appeal and the timing for the event to be held. Event funding levels are determined by the anticipated number of hotel room nights/overnight lodging in Leon County generated by the event.

All grant applicants are required to attend one of three workshops scheduled for July 26 at 3 p.m., Aug. 4 at 10 a.m. and Aug. 8 at 2 p.m. The workshops will take place in-person at the Leon County Facilities Management Building located at 1907 S. Monroe St. and will include an option for participants to attend virtually. Following the Aug. 8 workshop, a recording of the workshop will be made available on the Visit Tallahassee website.

## Leon County Administrator Vince Long Awarded the Top Honor



The International City/County Management Association (ICMA) has recognized Leon County Administrator Vince Long as the 2022 recipient of the Award for Career Excellence.

ICMA awards a \$5,000 stipend as part of the Award. Vince will grant the entire stipend to the Askew School of Public Administration and Policy at Florida State University to support and promote career excellence among local government professionals.

## Leon County wins National Award for Digital Excellence



For the tenth year in a row, Leon County Government was named one of the top-ranked digital county governments by the Center for Digital Government (CDG) and the National Association of Counties (NACo). Leon County placed first in Florida and fourth in its population category. The County has earned top rankings according to how it is harnessing technology to increase services and efficiencies within the organization and for its citizens.

Leon County remains dedicated to providing reliable and effective technology and telecommunication services across all government departments and to the ultimate end-customer, Leon County citizens. The award recognizes the County's ability to leverage innovative technologies that increase the County's efficiencies as well as enhance citizen engagement.

Over the past year, Leon County has implemented numerous technology initiatives and systems to improve internal efficiencies and deliver more effective services to residents while continuing to navigate the COVID-19 pandemic. Some of the initiatives that earned Leon County this achievement include:

- Implementation of Leon County's Text-to-9-1-1 program, which allows residents in need to send a text message directly to a 9-1-1 call taker
- Creation of the Leon County Vax Map, an online tool to locate COVID-19 vaccine, testing and treatment sites in Leon County
- Enhanced wireless connectivity in preparation for sporting events, like the NCAA Cross Country Championship, at the Apalachee Regional Park cross country course, providing access for ESPN and FSU broadcasting of events
- Creation of Leon County's Text-To-Inspect program, which allows contractors to utilize text messaging to schedule, reschedule, or cancel inspections and obtain inspection results on their Leon County building permits.

## Leon County Receives \$3.6 Million in Funding to Restore Old Concord School in Miccosukee



Earlier this month, Leon County Government was awarded a Community Development Block Grant (CDBG) of \$3.6 million for the restoration of the Concord School in Miccosukee. The CDBG award is in addition to \$1 million in federal funding Leon County received for the project as part of Congress' Fiscal Year 2022 appropriations bill, as well as a County match of \$850,000.

Before submitting for CDBG funds, the County conducted an extensive engagement plan to gather community input and inform the project's design. Specifically, the County convened a working group and hosted a series of public meetings in the Miccosukee area.

Funding will allow the County to make needed renovations purposed to improve functionality of the building and allow for future amenities. As this 1940 era building will be the only public gathering space in this rural community, the County's investment will ensure a critical site is available for the public to gather, receive needed services, and connect with neighbors. Further, the restored Concord School will have an emergency generator to serve as a comfort station during severe weather events to enhance community resilience.

Leon County, <u>Innovation Park Tallahassee</u>, and other community partners recently





The following is a summary of an interview of Amanda conducted by District 3 interns Aida, Camryn and Shubaum:

#### What initiatives did you take in your neighborhood?

- I helped repair the bad roads in our neighborhood.
- I took the initiative to reach out to Commissioner Minor and he accepted the invitation to a neighborhood meeting where he listened to our concerns.
- I helped get law enforcement to monitor vehicle speed near the school bus ramp.
- I helped to get stormwater issues in the neighborhood reduced.

#### What advice would you give to other neighborhoods?

"Whatever ideas you have or are trying to accomplish, follow up and follow through."

#### Why is being a good neighbor important?

"It's the relationships... it's always good to have good ones. It's always good to be able to help out. Everyone around me is family - we treat each other fairly, with respect."

### What advice would you give to future homeowners in your area that will help carry on your legacy?

- Be a worker.
- If you are going to do anything, make sure to follow through.
- Make sure what you are doing is in the best interest for everyone in the neighborhood.
- Good communication is key.

#### Amanda concluded by noting:

"This initiative and accomplishment would not have been possible without the assistance of neighbors like Joe and Jackie Stevens, Jerome Golden, Ocie Maddox, Elijah Vickers III, Sonny Herring Sr., and the late Sylvester Jones. These people were all willing to do what they could to ensure the roads were fixed prior to us finding out about the stabilization program. Mr. Maddox, Mr. Golden, and the late Sylvester Jones used their own or rented equipment to scrap/grade the roads and with guidance from the County Office, were all willing to learn what they could do to solve some of the issues we were having with draining and yards flooding. The whole neighborhood really deserves a standing ovation."
