1. Besides the original bid should copies be submitted? If so, how many?
2. Please provide invoices and manifests for the last contract year?
3. How much did Leon County pay for pickup, transportation, and disposal of hazardous waste from the Leon County Hazardous Waste Center during the last contract year?
4. How many pickups occurred during the last contract year?
5. What is the anticipated start date for this contract?
6. Will a forklift be provided for contractor use?
7. Is the Leon County Hazardous Waste Center accessible to tractor trailers?
8. Does the Leon County Hazardous Waste Center have a loading dock?
9. Regarding the scope of services as summarized in RFP pg 2, "PURPOSE", please confirm that Leon County will be responsible for labeling, packaging, and segregation and the awarded vendor will be responsible for pickup, transportation and disposal of hazardous waste materials?
10. Regarding RFP pricing sheets on page 14 and page 17, what is the difference between the two? They appear to be identical. Which price sheet should be completed or should both be completed? Please clarify.

Questions

1. Regarding the "Bulked Material" section, there is not a category for bulked flammable liquids. Are bulked flammable liquids being handled under a separate contract? Will the bid pricing sheet be amended to include a waste category for bulk flammable liquids?
2. Regarding "Inventoried Lab Pack Material", can the acceptable disposal method for Flammable liquids also include fuel blending, which is also a thermal treatment method, in addition to incineration?
3. Please provide clarification on Spent Methamphetamine One-Pots. What is the source of this waste stream?
4. In addition to residents, do local government agencies and small businesses also bring their waste to the Leon County Hazardous Waste Center?
5. Are the methods of disposal listed in the bid pricing sheet based on the methods being utilized by the current vendor or were they chosen at the sole discretion of the County?

Answers

1. We do not do a separate bulked flammable liquids. We bulk oil paints and stains, along with small amounts of other flammable liquids. Otherwise, these are lab packed.
2. Yes.
3. These come from law enforcement lab cleanouts.
4. We also run a CESQG program and those wastes are commingled with HHW.
5. Both. They are used by current vendor and have historically been used by the program.
