The 2015 County Budget & Blueprint 2020

2015 Budget

The County Commission will hold the first of two budget workshops on June 10th (9am until 3pm) to continue the development the 2015 fiscal year budget. A second workshop is scheduled for July 8-9 to put the final touches on the budget. Two public hearings are also scheduled in September (Sept. 16 & Sept. 23) where citizens will have the opportunity to weigh in on the budget (view the workshop agenda and materials [here](#)).

Blueprint 2020


The Commission will also hold the first and only public hearing on a proposed ordinance to extend the current local government infrastructure surtax (Blueprint 2020). The existing one-cent infrastructure sales tax expires December 31, 2019. The sales tax currently generates approximately \$37.8 million annually and is shared between the County, City, and Blueprint 2020. Approval of an ordinance is necessary to continue the collection of the sales tax and will be placed on the November 4, 2014 General Election Ballot.

This public hearing will take place at 6pm on June 6th in the County Commission Chamber, and citizens are encouraged to attend and comment (view background materials for the public hearing [here](#)).

Have a Plan. Be Prepared for Hurricane Season.


