Business Incubator Grand Opening

Leon County in partnership with Florida State University and Domi Ventures will open the new Domi Ventures business incubator on Thursday, May 22nd..

The facility is located on Railroad Avenue across from the Amtrak Station, and will provide offices for new firms, co-working space, and various support functions, as well as access to mentors and potential investors.

The development of the Domi incubator is a result of Leon County's and Florida State University's support of entrepreneurs and growing the local economy.

LCRDA/Innovation Park "Elevator Pitch" Night

The Leon County Research & Development Authority (LCRDA) will host its 3rd Annual Elevator Pitch Night on Wednesday, May 14th, at the Goodwood Carriage House Conference Center from 5:30 p.m. until 7:30 p.m.



Five local start-up companies, selected from a pool of 18 applicants, will compete for Technology Commercialization Grants given by the LCRDA, and the winners will split a total of \$30,000 to help their start-ups gain momentum.

The companies will each present a five-minute "elevator pitch" presentation to a panel of judges and other guests, and at the end of the night the winners will be announced.

The five finalists are: General Capacitor, InnoMedicine, ReclaimRx, Specialized Crystal Processing, Stadium Runner

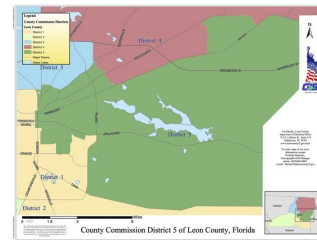
