

Due to the BluePrint 2000 Capital Circle NW/SW improvement project, Norman Drive, which is located off Pensacola Street and parallels Capital Circle SW was realigned and now connects to the Blountstown Street Service Road creating one continuous roadway. As a result of the one continuous roadway both segments have been renamed to 'NORMAN PARK DR.' This roadway now provides a direct connection between Capital Circle SW and Blountstown Street.
