

The Prefixes are:

LAP -- Leon County Abandoned Property Registry (This is used to track property that has been foreclosed on and has not been resold for occupancy)

LDV -- Leon County Internal Zoning Review (this is usually connected to a building permit)

LB -- Leon County Building Permit (This can be anything from new construction single family to a water heater replacement)

LEC -- Leon County Code Violation (This can be for Environmental Code, Building Code, Junk, Litter, Mowing, etc...)

LT -- Leon County Telephone/Web/Septic Permit (This is for permits that need no plans review and can be issued over the counter; Septic is used to track septic installations in the County system)

LPR -- Leon County Project Review (This is where the review for a building or environmental permit is performed, dates and times tracked. This also allows staff to group several associated processes LDV, LB, and LDR into a single review string)

LPQ -- Leon County Project Review Quick (Used for projects with a review cycle of one business day or less)

LDR -- Leon County Driveway Permit (This is for installation of an access point to a county maintained road)

LEM -- Leon County Environmental Permit (This permit ensures that development is in accordance with the Environmental section of the Leon County Code of Laws)

LEA -- Leon County Environmental Impact Analysis (Part 1 is a Natural Features Inventory, Part 2 is an Impact Analysis with regard to the environment)

LAB -- Leon County As-Built (This permit reflects the actual stormwater facilities created with the LEM permit)

LSW -- Leon County Stormwater Permit (This provides for the schedule of inspections to maintain and track, volume, capacity, discharge, and general condition of stormwater facilities)

LO -- Leon County Stormwater Permit (old permits)

LTW -- Leon County Tower Bond Tracking (The tracking of Bonds posted for tower and tank removal in case of principal default)

LVM -- Leon County Vegetative Management Permit (Provides for a maintenance plan and scheduled inspections to ensure that landscaping continues to thrive in accordance with the LEM)

LSP -- Leon County Site/Development Plan (This is for commercial property development, creation of residential subdivision of land in accordance with state statutes and the county code of laws)

LPA -- Leon County Pre-Application meeting (This is associated to an LSP for the creation of a Planned Unit Development PUD)

LEX -- Leon County Exempt Subdivision (This process allows for the creation of subdivided lots in accordance with the family heir clause in the county code of laws, it also provides methods of exception as a remedy to improperly subdivided lots)

VC -- Leon County Permitted Use Verification (This process is used to determine if the proposed land use is in accordance to zoning and land use regulations)

LCM -- Leon County Concurrency Management Permit (This process is used to determine the infrastructure requirements for an associated development LSP, traffic, water, sewer, schools, solid waste, etc...)

LS -- Leon County Off-Site Sign Inventory (This process tracks the number and location of these types of signs and restricts the total number to a fixed amount)

LMS -- Leon County Miscellaneous (Internal tracking and fee collection for unassociated items)

LDEV -- Leon County Development Tracking (This is used to combine groups of projects LPR's that are associated)
