3 AN ORDINANCE OF THE BOARD OF COUNTY
4 COMMISSIONERS OF LEON COUNTY, FLORIDA,
5 AMENDING CHAPTER 4, ARTICLE II, DIVISION 2 OF
6 THE CODE OF LAWS OF LEON COUNTY, FLORIDA,
7 REGARDING IMPOUNDMENT, REDEMPTION, ETC.;
8 AMENDING SECTION 4-65 ENTITLED "FEES"
9 PROVIDING FOR CONFLICTS; PROVIDING FOR
10 SEVERABILITY; AND PROVIDING AN EFFECTIVE
11 DATE.

13 BE IT ORDAINED by the Board of County Commissioners of the County of Leon,
14

15 Florida, as follows, that:

16 **Section 1.** Section 4-65 of the Code of Laws of Leon County, Florida, is hereby amended to
17 read as follows:

18 Impoundment and board fees for animals under this division shall be as follows:

19 (1) ~~Impoundment, \$30.00.~~ Impound fees for each animal shall be established by a
20 resolution of the board.

21 (2) Boarding fees, for each day the animal is impounded or partial day thereof, shall
22 be established by a resolution of the board.

23 **Section 2.** **Conflicts.**

24 All ordinances or parts of ordinances in conflict with the provisions of this ordinance are
25 hereby repealed to the extent of such conflict, except to the extent of any conflicts with the
26 Tallahassee-Leon County 2010 Comprehensive Plan as amended, which provisions shall prevail
27 over any parts of this ordinance which are inconsistent, either in whole or in part, with the said
28 Comprehensive Plan.

29 **Section 3.** **Severability.**

1 If any section, Subsection, sentence, clause, or provision of this ordinance is held invalid,
2 the remainder of the ordinance shall not be affected by such invalidity.

3 **Section 4 Effective Date.**

4 This ordinance shall have effect upon becoming law.
