INTERLOCAL AGREEMENT

This is an Agreement entered into between the Miccosukee Volunteer Fire Department, Inc., the Lake Jackson Volunteer Fire Department, Inc., the Woodville Volunteer Fire Department Inc., the Chaires-Capitola Volunteer Fire Department, Inc., the Lake Talquin Volunteer Fire Department, Inc., and the Miccosukee Land Co-Op Volunteer Fire Department, Inc., by which the undersigned parties have entered into a Mutual Aid Agreement with the Tallahassee Fire Department and agree to jointly provide fire protection services to the unincorporated area of Leon County, Florida.

Whereas, it is believed that each of the undersigned parties and the public will benefit if such fire protection services are provided jointly by the entities cooperating under this Joint Venture Agreement, Now, Therefore,

IT IS THEREBY AGREED AS FOLLOWS:

1. Purpose. The undersigned parties shall provide fire protection services and first responder medical aid in the unincorporated areas of Leon County, Florida, in coordination with the Tallahassee Fire Department, pursuant to the Mutual Aid Agreement entered into by each of the undersigned with the Tallahassee Fire Department and in accordance with the Fire Services Agreement entered into by the City of Tallahassee and Leon County, Florida.

2. Creation of Joint Venture Organization. There is hereby created a joint venture organization called the "LEON COUNTY VOLUNTEER FIRE SERVICES". The undersigned parties hereby assign to such organization the responsibility for coordinating fire protection services and first responder medical aid to fires and injuries which occur in the unincorporated area of Leon County, Florida, subject to the provisions of the Mutual Aid Agreement and the Fire Services Agreement referred to in # 1 above. The administrative board provided in section 3 of this Agreement shall constitute a "Joint Board".

3. Board Membership. The "Joint Board" of Leon County Volunteer Fire Services will be composed of one representative appointed by each of the undersigned parties. Members of the "Joint Board" shall serve at the pleasure of the Department they represent. Representatives shall not be paid for serving on the Joint Board. Representatives will be responsible for reasonable expenses for the attendance at meetings of the Joint Board. Nothing herein shall be construed so as to prevent the undersigned parties from reimbursing their representatives for any expenses incurred, nor preventing the compensation of such representatives for their services.

4. Duration. This Agreement shall be of a minimum duration of five (5) years. Unless terminated or modified by

the undersigned parties, this Agreement shall continue in effect indefinitely.

5. Additional Members. This Agreement shall be amended to allow the addition of members in the Leon County Volunteer Fire Services organization. A volunteer fire department providing fire services to any of the unincorporated areas of Leon County, Florida, which is recognized by the Board of County Commissioners of Leon County, Florida, and also enters into a Mutual Aid Agreement with the Tallahassee Fire Department after the effective date of this Agreement, shall be required to become a party to this Agreement. New parties to this Agreement shall be entitled to representation on the "Joint Board".

6. Severance. If any section, phrase, sentence, portion, or application of this Agreement is for any reason held invalid by any court of competent jurisdiction, such a portion or application shall be deemed a separate, distinct, and independent provision or application, and such holding shall not affect the validity of any of the remaining portions or applications thereof.

7. Conflict. If any section, phrase, sentence, portion, or application of this Agreement is found to conflict with any of the provisions of the Mutual Aid Agreement or Fire Services Agreement, the Fire Services Agreement or Mutual Aid Agreement shall prevail.

8. Effective Date. This Agreement shall take effect upon the signing by all parties of such Agreement.
