**SUBJECT** Community Centers and Recreation Councils

At the June 26 2007 regular meeting the Board considered options relating to the continuance or elimination of certain Board appointed committees. The action taken by the Board was to accept staff's recommendation excluding the elimination of Community Center Focus Groups and Recreation Councils.

At the October 23 2007 regular meeting the Board had further discussion about the purpose of the Community Center Focus Groups and Recreation Councils. Furthermore, the Board expressed a desire to individually evaluate those groups and report back as to the results of the evaluations. To assist with those efforts staff has prepared a list of all members of Community Center Focus Groups and Recreation Councils along with their contact information (Attachment #1).

Each focus group is facilitated/chaired by Leon County staff person Jan Taylor with the Division of Parks and Recreation. In addition the Recreation Councils do not have a formal leadership structure consequently all names have been provided for each of those groups as well.
