Collect fees, donations, and other revenues, for the exclusive purpose of expanding sports and recreation programs and facilitating park improvements

Promote, publicize, and advertise information pertaining to youth sports programming

Assist the County in the protection and security of park facilities under the Council's jurisdiction

Promote the spirit of community involvement by holding at least one town meeting annually for the purpose of soliciting programming ideas from the community
