### Terms

Initial terms staggered four 2 year terms, three 1 year terms, thereafter all terms 2 years Terms expire July 31 No limit on number of terms allowed Vacancies filled for remainder of unexpired term

- Representatives of four interest groups
- 1 conservation/environment
  - 2 legal/planning
  - 3 real estate/economic development
  - 4 boating/fishing
