Subject: committee appointment vacancies

After retiring from 15 years of public service in Texas as the Director of Program Management and Compliance at the Texas Department of Housing and Community Affairs (TDHCA), I have finally returned to Florida. My husband and I am now living in Tallahassee, looking for farmland to purchase and become permanent residents of the county.

I am very interesting in becoming active in public service again, and am very open to filling a vacancy as a committee member. Affordable housing is my first choice, but given my background in most every federally or state sponsored grant program, I believe that my expertise would be valuable to the county in several other committees. In addition to most every housing program, I am also very well versed in the Community Development Block Grant, Community Service Block Grant, LIHEAP, weatherization, Section 8 (both tenant and project based) the HOME program, etc.

The role I fulfilled at TDHCA is most simply described as follows: Once TDHCA made awards or issued contracts, it was my responsibility to administer and monitor the expenditure of any program administered by TDHCA until the contract ended.

My position at TDHCA made it very easy to fulfill a lifelong commitment to advocate for those whose voice is routinely drowned out by others. I had to justify expenditure of funds, and provide clear documentation that monies spent by the state reached the intended recipients. The career at TDHCA was the culmination of a long history of working with the community and poverty programs. My first "real job" was in Atlanta Georgia as a youth counselor for the city's parks and recreation department. I was assigned to Techwood Apartments, which was the first federally funded public housing community.

I also served for many years as a Director for The National Housing Conference, a group whose mission included the advocacy for rights of the low income individuals and families. While it was many years ago, I served as an adviser to the Collier County Commission in their effort to create affordable housing within the city, Immokolee, and the county at large. However most of my time was spent working with the committee charged with creating the "housing element" of the county's comprehensive housing plan.

I have downloaded an application for an appointment and will work on it during the upcoming holidays. Candace Wilson graciously invited me to a recent Affordable Housing committee meeting and provided me direct access to the county's web page. However I did want to open a dialog with you, so that I could acquire a wider view of what roles might be available to me in the new year.
