Acts as advisory committee to the City and County Commissions, other governmental agencies within the metropolitan area, Individuals, and private agencies seeking its advice and assistance in comprehensive planning and development of the Tallahassee area.

A chairman and vice chairman are elected for a one-year term in September.

### Terms:

3 year terms, extending from July 1. Number of terms allowed: Bylaws allow members to serve two 3-year terms, and may fill unexpired remainder of another term. Vacancies filled for remainder of unexpired term.

### Eligibility Criteria:

Must be residents of Leon County, but shall not be appointed from the membership of any planning/ and or zoning board operating within the exclusive jurisdiction of each government unit.
