A Resolution Certifying a Non-Ad Valorem Assessment Roll
Applicable to Improved Residential Real Property in Oakhill Farms
Subdivision to the Tax Collector.

WHEREAS, Section 197.3632(6), Florida Statutes, specifically authorizes the collection of special assessments to be amortized over a period of years, which Leon County elected to utilize for the assessment applicable to improved residential real property in the Oakhill Farms Subdivision service area; and

WHEREAS, Section 197.3632(5), Florida Statutes, requires the Chair of the Board of County Commissioners to certify a non-ad valorem assessment roll on compatible electronic medium to the Tax Collector by September 15th of each year.
