The purpose of the authority shall be to assist institutions for higher education in the construction, financing, and refinancing of projects, and this purpose the authority is authorized and empowered as set forth in Chapter 243.22, Florida Statutes.

Appointments:

7 members. Each commissioner appoints one member

Terms:

Initial terms were 1 through 5 years; thereafter, all are 5 years. Terms expire July 31. Number of terms allowed not specified. Vacancies filled for remainder of an unexpired term.

Eligibility Criteria:

All members must be residents of Leon County. At least one must be a trustee, director, officer or employee of an institution for higher education.

Schedule:

Quarterly (October, January, April, and July), or as needed.

Type of Report:

Within first 90 days of each calendar year, reports to the BCC its activities for the preceding calendar year
