

RESOLUTION NO. 09-38

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEON COUNTY, FLORIDA, TO ESTABLISH AN ADVISORY COMMITTEE WHICH SHALL BE NAMED THE LEON COUNTY HUMAN RELATIONS ADVISORY COMMITTEE AND WHICH SHALL OPERATE AND FUNCTION AS A DECISION MAKING COMMITTEE.

WHEREAS, the Board of County Commissioners of Leon County, Florida (the Board) recognizes and acknowledges the importance of public involvement and input in County government; and

WHEREAS, in order for the Board to consider the input of the public in the matter of nondiscrimination and other human relations issues in Leon County, it wishes to establish and appoint an advisory committee to function and operate in accordance with Board Policy No. 03-15, Board-Appointed Advisory Committees: Establishment, Appointment, Function, Operation, and Dissolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEON COUNTY, that:

1. The Board hereby establishes an advisory committee, to be named the Leon County Human Relations Advisory Committee, for the purpose of serving as an advisory and public policy sounding board and to study nondiscrimination and other human relations issues in Leon County.
2. The Leon County Human Relations Advisory Committee shall function and operate as a Decision Making Committee in accordance with Board Policy No. 03-15, Board-Appointed Advisory Committees: Establishment, Appointment, Function, Operation, and Dissolution.
3. The Leon County Human Relations Advisory Committee shall have as its goal to study nondiscrimination and other human relations issues in Leon County and to report back to the Board with recommendations as applicable.
4. The Leon County Human Relations Advisory Committee shall be charged with the responsibility of giving input to the Board as follows: making recommendations to the Board annually, or as needed, in the form of a written report.

5. The Leon County Human Relations Advisory Committee shall have seven (7) members to be appointed as follows: each Commissioner of the Board shall choose one member.

6. The members of the Leon County Human Relations Advisory Committee shall not be subject to full and public disclosure of financial interests.

7. The Leon County Human Relations Advisory Committee shall be assisted by staff as designated by the County Administrator

8. The Leon County Human Relations Advisory Committee shall be dissolved only upon direction of the Board.

9. This resolution shall become effective immediately upon its adoption.
