Eligibility Criteria:

The contractors licensing and examination board shall consist of seven
 members to be appointed by the Board of County Commissioners. Such
 board shall include whenever possible, one architect or engineer, one
 business person, one general contractor or other contractor (building &
 residential) who is registered or certified under Section 489.105(3)(a) (c
 F.S., one pool contractor or other contractor (building, residential, or
 general) who is registered or certified under Section 489.105(3)(d) (o).
 and three consumer representatives who may be any resident of Leon
 County that is not, and has never been, a member or practitioner of a
 profession regulated by the contractors licensing and examination board
 member of any closely related profession. All members of the board, exc
 for the consumer representatives, shall be licensed in this state and acti
 engaged in the profession they represent on such board. All members sh
 be voters registered in the County.
