The MWSBE Division has reviewed the participation plans for 6 firms, to determine the MBE and WBE participation levels on the point scale below. GGI, LLC d/b/a Genesis Group received 10 points, as they committed to a joint venture and committed to meet or exceed both aspirational targets. Dyer, Riddle, Mills & Precourt, Inc., Baskerville-Donovan, Inc., and Reynolds, Smith and Hills, Inc. received 8 points, as they committed to meet or exceed both aspirational targets. GPI Southeast, Inc. received 6 points, as they committed to meet at least 50% of both aspirational targets and submitted a Good Faith Effort Statement that the MWSBE Director accepts. Post, Buckley, Schuh & Jernigan d/b/a PBS&J received 0 points, as they did not commit to the utilization of any certified MBE and WBE firms and did not submit a Good Faith Effort Statement; therefore the Purchasing Director has deemed this firm as non-responsive.
