Responsibility:

Develops plans for tourist development; makes recommendations for operation of special projects or for uses of tax revenue. Reviews expenditures of revenue from the development trust fund.

Created By:

Ch. 125.0104(4)(e), F.S.
County Ordinance 88-01
County Resolution establishing the Council, 10/20/1986

Appointments:

9 members

9 - BCC

Terms:

4 year terms. Terms expire October 31. Number of terms allowed not specified in statute or ordinance. Vacancies are filled for remainder of unexpired term.

Eligibility Criteria:

- 1 - Chairman of the BCC or Chairman may designate any other County Commissioner
- 2 - City Commissioners (Elected Municipal Officials)
- 3 - Owners or operators of hotels, motels, recreational vehicle parks, or other tourist accommodations in the County and subject to the tax
- 3 - Persons involved in the tourist industry and who have demonstrated interest in tourist development, but who are not owners or operators of hotels, motels, recreational vehicle parks, or other tourist accommodations in the County and subject to the tax.

All must be electors of the County.
