Responsibility:

PURPOSE:

1. Function as a standing committee that will make recommendations to City and County Commissions on matters related to Canopy Road preservation.
2. Assist in coordinating efforts of government, private sector, civic group and individuals in an effort to protect, maintain, enhance and where applicable, re-evaluate Canopy roads.

Created By:

BCC created ad hoc on October 8, 1991.
Made standing committee by both commissions in January 1993.

Appointments:

8 members

- 4 - BCC
- 4 - City Commission
- 1 - Chairman appointment (ex -officio)

Terms:

Number of terms allowed - Two consecutive three-year terms.
Terms expire October 31.
Vacancies filled for remainder of unexpired term.

Eligibility Criteria:

Members should consist of a balance of persons who have expertise in field of forestry, local history, who live along a Canopy Road or who have demonstrated a willingness to serve for the enhancement of the community. An ex-officio, non-voting member shall be included from the Apalachee Conservancy. Members of other groups may also be included as non-voting ex-officio members at the discretion of the committee.
