I. INTRODUCTION

Leon County is requesting proposals to obtain vocational services and case management to reduce recidivism in the Leon County Jail. The Committee will screen proposals and will recommend to the Leon County Board of County Commissioners the service providers which can provide requested services in the most cost effective manner. The purpose of this Request for Proposals is to secure qualification statements and proposed costs from agencies who have proven prior experience in vocational training and case management of incarcerated adults involved in the judicial system. Proposed services will focus on vocational training.

This will be a partnership among the Courts, Office of the State Attorney, Public Defender's Office, Leon County Probation Division, Leon County Pre-Trial Release Program, Leon County Sheriffs Office and lastly, the providers of the proposed services.

Pre-Proposal Conference:

A **MANDATORY** Pre-Proposal Conference is scheduled for Tuesday, March 23, 2010 at 9:30 AM and will be held in the and will be held in the Administration Conference Room, Leon County Jail, 535 Appleyard Dr., Tallahassee, FL. The pre-bid conference may be followed by a tour, if needed, and will go as long as necessary up to 12:00 PM. The conference/tour will cover the jail environment, security and operational factors for Respondents, and provide access to Jail personnel for questions and answers.

B. **Proposal Copies:** **An ORIGINAL and five (5) copies** of the Response must be furnished on or before the deadline. Responses will be retained as property of the County. **The ORIGINAL of your reply must be clearly marked "Original" on its face and must contain an original, manual signature of an authorized representative of the responding firm or individual**, all other copies may be photocopies.

Each Vendor shall examine the request for proposal documents carefully; and, no later than seven days prior to the date for receipt of proposals, he shall make a written request to the County for interpretations or corrections of any ambiguity, inconsistency or error which he may discover. All interpretations or corrections will be issued as addenda. The County will not be responsible for oral clarifications. No negotiations, decisions or actions shall be initiated or executed by the proposer as a result of any discussions with any County employee prior to the opening of proposals. Only those communications which are in writing from the County may be considered as a duly authorized expression on the behalf of the Board.

Also, only communications from firms which are in writing and signed will be recognized by the Board as duly authorized expressions on behalf of proposers.

- D. Prohibited Communications: Any Form of communication, except for written correspondence, shall be prohibited regarding a particular request for proposal, request for qualification, bid, or any other competitive solicitation between:
1. Any person or person's representative seeking an award from such competitive solicitation; and
 2. Any County Commissioner or Commissioner's staff, or any county employee authorized to act on behalf of the Commission to award a particular contract.

For the purpose of this section, a person's representative shall include, but not be limited to, the person's employee, partner, officer, director, consultant, lobbyist, or any actual or potential subcontractor or consultant of the person. The prohibited communication shall be in effect as of the deadline to submit the proposal, bid, or other response to a competitive solicitation.

The provisions of this section shall not apply to oral communications at any public proceeding, including pre-bid conferences, oral presentations before selection committees, contract negotiations during any public meetings, presentations made to the Board, and protest hearings. Further, the provisions of this section shall not apply to contract negotiations between any employee and the intended awardee, any dispute resolution process following the filing of a protest between the person filing the protest and any employee, or any written correspondence with any employee, County Commissioner, or decision-making board member or selection committee member, unless specifically prohibited by the applicable competitive solicitation process.

The provisions of this section shall terminate at the time the Board, or a County department authorized to act on behalf of the Board, awards or approves a contract, rejects all bids or responses, or otherwise takes action which ends the solicitation process.

The penalties for an intentional violation of this article shall be those specified in §125.69(1), Florida Statutes, as amended, and shall be deemed supplemental to the penalties set forth in Section 1-9 of the Code of Laws, Leon County, Florida.

- E. - G. Proposal Deadline: Your response to the RFP must arrive at the above listed address no later than Wednesday, April 14, 2010 at 2:00 PM to be considered.
- H. Responses to the RFP received prior to the time of opening will be secured unopened. The Purchasing Agent, whose duty it is to open the responses, will decide when the specified time has arrived and no proposals received thereafter will be considered.
- I. The Purchasing Agent will not be responsible for the premature opening of a proposal not properly addressed and identified by Proposal number on the outside of the envelope/package.
- J. It is the Proposers responsibility to assure that the proposal is delivered at the proper time and location. Responses received after the scheduled receipt time will be marked "TOO LATE" and may be returned unopened to the vendor.
- K. The County is not liable for any costs incurred by bidders prior to the issuance of an executed contract.
- L. Firms responding to this RFP must be available for interviews by County staff and/or the Board of County Commissioners. **Interviews are at the discretion of the Evaluation Committee appointed by the County Administrator.**
- M. The contents of the proposal of the successful firm will become part of the contractual obligations.
- N. Proposal must be typed or printed in ink. All corrections made by the Proposer prior to the opening must be initialed and dated by the Proposer. No changes or corrections will be allowed after proposals are opened.
- O. If you are not submitting a proposal, please return the form attached at the end of the RFP, marked 'No Proposal'.
- P. The County reserves the right to reject any and/or all proposals, in whole or in part, when such rejection is in the best interest of the County. Further, the County reserves the right to withdraw this solicitation at any time prior to final award of contract.
- Q. Cancellation: The contract may be terminated by the County without cause by giving a minimum of thirty (30) days written notice of intent to terminate. Contract prices must be maintained until the end of the thirty (30) day period. The County may terminate this agreement at any time as a result of the contractor's failure to perform in accordance with these specifications and applicable contract. The County may retain/withhold payment for nonperformance if deemed appropriate to do so by the County.
- R. Public Entity Crimes Statement: A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list. By submission of a proposal in response to this document, the vendor certifies compliance with the above requirements as stated in Section 287.133, Florida Statutes.

- S. Certification Regarding Debarment, Suspension, and Other Responsibility Matters: The prospective primary participant must certify to the best of its knowledge and belief, that it and its principals are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any Federal department or agency and meet all other such responsibility matters as contained on the attached certification form.
- T. Licenses and Registrations: The contractor shall be responsible for obtaining and maintaining throughout the contract period his or her city or county occupational license and any licenses required pursuant to the laws of Leon County, the City of Tallahassee, or the State of Florida. Every vendor submitting a bid on this invitation for bids **shall** include a copy of the company's local business or occupational license(s) or a written statement on letterhead indicating the reason no license exists. Leon County, Florida-based businesses are required to purchase an Occupational License to conduct business within the County. Vendors residing or based in another state or municipality, but maintaining a physical business facility or representative in Leon County, may also be required to obtain such a license by their own local government entity or by Leon County. If the contractor is operating under a fictitious name as defined in Section 865.09, Florida Statutes, proof of current registration with the Florida Secretary of State **shall be submitted** with the bid. A business formed by an attorney actively licensed to practice law in this state, by a person actively licensed by the Department of Business and Professional Regulation or the Department of Health for the purpose of practicing his or her licensed profession, or by any corporation, partnership, or other commercial entity that is actively organized or registered with the Department of State **shall submit** a copy of the current licensing from the appropriate agency and/or proof of current active status with the Division of Corporations of the State of Florida or such other state as applicable.

Failure to provide the above required documentation may result in the bid being determined as non-responsive.

U. Audits, Records, And Records Retention

The Contractor shall agree:

1. To establish and maintain books, records, and documents (including electronic storage media) in accordance with generally accepted accounting procedures and practices, which sufficiently and properly reflect all revenues and expenditures of funds provided by the County under this contract.
2. To retain all client records, financial records, supporting documents, statistical records, and any other documents (including electronic storage media) pertinent to this contract for a period of five (5) years after termination of the contract, or if an audit has been initiated and audit findings have not been resolved at the end of five (5) years, the records shall be retained until resolution of the audit findings or any litigation which may be based on the terms of this contract.
3. Upon completion or termination of the contract and at the request of the County, the Contractor will cooperate with the County to facilitate the duplication and transfer of any said records or documents during the required retention period as specified in paragraph 1 above.
4. To assure that these records shall be subject at all reasonable times to inspection, review, or audit by Federal, state, or other personnel duly authorized by the County.

5. Persons duly authorized by the County and Federal auditors, pursuant to 45 CFR, Part 92.36(l)(10), shall have full access to and the right to examine any of provider's contract and related records and documents, regardless of the form in which kept, at all reasonable times for as long as records are retained.
6. To include these aforementioned audit and record keeping requirements in all approved subcontracts and assignments.

V. Monitoring

To permit persons duly authorized by the County to inspect any records, papers, documents, facilities, goods, and services of the provider which are relevant to this contract, and interview any clients and employees of the provider to assure the County of satisfactory performance of the terms and conditions of this contract.

Following such evaluation, the County will deliver to the provider a written report of its findings and will include written recommendations with regard to the provider's performance of the terms and conditions of this contract. The provider will correct all noted deficiencies identified by the County within the specified period of time set forth in the recommendations. The provider's failure to correct noted deficiencies may, at the sole and exclusive discretion of the County, result in any one or any combination of the following: (1) the provider being deemed in breach or default of this contract; (2) the withholding of payments to the provider by the County; and (3) the termination of this contract for cause.

W. Local Preference in Purchasing and Contracting

1. Preference in requests for proposals. In purchasing of, or letting of contracts for procurement of, personal property, materials, contractual services, and construction of improvements to real property or existing structures for which a request for proposals is developed with evaluation criteria, a local preference of the total score may be assigned for a local preference, as follows:

- a) Individuals or firms which have a home office located within Leon, Gadsden, Wakulla, or Jefferson County, and which meet all of the criteria for a local business as set forth in this article, shall be given a preference in the amount of five percent.
- b) Individuals or firms which do not have a home office located within Leon, Gadsden, Wakulla, or Jefferson County, and which meet all of the criteria for a local business as set forth in this article, shall be given a preference in the amount of three percent.

2. Local business definition. For purposes of this section, "local business" shall mean a business which:

- a) Has had a fixed office or distribution point located in and having a street address within Leon, Gadsden, Wakulla, or Jefferson County for at least six (6) months immediately prior to the issuance of the request for competitive bids or request for proposals by the County; and
- b) Holds any business license required by Leon County, and, if applicable, the City of Tallahassee; and
- c) Is the principal offeror who is a single offeror; a business which is the prime contractor and not a subcontractor; or a partner or joint venturer submitting an offer in conjunction with other businesses.

3. Certification. Any vendor claiming to be a local business as defined, shall so certify in writing to the Purchasing Division. The certification shall provide all necessary information to meet the requirements of above. The Local Vendor Certification Form is

enclosed. The purchasing agent shall not be required to verify the accuracy of any such certifications, and shall have the sole discretion to determine if a vendor meets the definition of a "local business."

Z. Unauthorized Alien(s): The Contractor agrees that unauthorized aliens shall not be employed nor utilized in the performance of the requirements of this solicitation. The County shall consider the employment or utilization of unauthorized aliens a violation of Section 274A(e) of the Immigration and Naturalization Act (8 U.S.C. 1324a). Such violation shall be cause for unilateral termination of this Agreement by the County. III. SCOPE OF SERVICES

A. OVERVIEW

Leon County is requesting proposals to obtain vocational services and case management to reduce recidivism in the Leon County Jail. The Committee will screen proposals and will recommend to the Leon County Board of County Commissioners the service providers which can provide requested services in the most cost effective manner. The purpose of this Request for Proposals is to secure qualification statements and proposed costs from agencies who have proven prior experience in vocational training and case management of incarcerated adults involved in the judicial system.

This will be a partnership among the Courts, Office of the State Attorney, Public Defender's Office, Leon County Probation Division, Leon County Pre-Trial Release Program, Leon County Sheriffs Office and lastly, the providers of the proposed services.

Proposed services will focus on vocational training for incarcerated individuals (and those who may be released during the training period). Service providers(s) shall have clearly defined programs of pre-determined length with program milestones and outcome measures.

Experience in the criminal justice system and understanding of the Florida Courts and adult Criminal Justice System is preferred. Selection will be made considering the ability of professional personnel; past performance; budget requirements; and recent, current, and projected workload of the proposer(s).

Proposers should provide evidence for demand of employability and the vocational skills to be trained in the program within the Big Bend Area.

B. SPECIFIC DETAILS OF DIVERSION THROUGH VOCATIONAL TRAINING PILOT PROGRAM

1. The purpose of the Diversion Through Vocational Training Program is to:
 - a. Reduce recidivism and criminality by the offenders;
 - b. Lessen the demand on County jail beds; and
 - c. Provide employable skill sets to non-violent offenders.
2. Program outcomes may include:
 - a. A reduced demand on County jail beds;
 - b. Cost savings to the County by diverting offenders from the jail.
 - c. Training non-violent offenders with employable skill sets.
 - d. Tracking individual clients by name, SPN #, type of offense, date(s) arrested, type. of vocational training, attendance records, re-offenses and individual case studies to be submitted quarterly to the Leon County Public Safety Coordinating Council.
3. Pilot Program targeted population includes persons in need of vocational training in order to seek employment opportunities and may include offenders transitioning to the re-entry process.

IV. REQUIRED SUBMITTALS:

A. BACKGROUND AND EXPERIENCE

1. The provider shall be a licensed organization with the State of Florida. A copy of licensure shall be included in the proposal.
2. The provider should include a description of organizational qualifications that describe the following:
 - a. Firm/Joint Venture name, business address and office location, telephone number.

3. The provider shall be in good standing with any State or Federal Agency that has a contracting relationship with the provider.

5. A current organizational chart should be included which shows the lines of authority within the organization and parent organization, if applicable. Include the effective date on the chart. The proposed program should be clearly marked with proposed staff positions identified.
6. The provider will describe previous and current experience in working with the courts, criminal justice agencies, and social services agencies, if any.
7. The provider shall have developed working relationships with referral sources and organizations that will address other ancillary needs of the target population. Such working relationships shall be demonstrated through letters of agreement attached to your response to this RFP.

B. PROGRAM NARRATIVE: Your proposal narrative should address the following:

1. Program services description: Proposals should include a brief description of the particular service proposal, what the service consists of, and who will perform services.
2. Program services consist of:
 - a. Training
 - b. Job Placement
 - c. Job Counseling
 - d. Job Retention
3. Program site(s) where re-entry and/or case management services would be provided: description of the facility(ies), location, accessibility to bus routes/public transportation, hours of operation, and security

C. COST DATA

1. The proposal should describe reasonable and per unit cost of proposed services. This schedule and procedure should accommodate the following contract stipulations:
 - a. A per unit charge for each proposed services provided to participants in the services of:
 - 1) Vocational Training
 - 2) Vocational Counseling
 - 3) Job Placement
 - b. Address additional costs that may be in addition to your above unit costs.
 - c. A maximum of \$100,000.00 can be billed under the awarded contract.

D. REQUIRED FORMS

V. SELECTION PROCESS

- A. The County Administrator shall appoint an Evaluation Committee composed of three to five members who will review all proposals received on time, and may select one or more firms for interview based on the responses of each proposer. All meetings of Evaluation Committees subsequent to the opening of the solicitation shall be public meetings. Notice of all meetings

shall be posted in the Purchasing Division Offices no less than 72 hours (excluding weekends and holidays) and all respondents to the solicitation shall be notified by facsimile or telephone.

- B. The Evaluation Committee will recommend to the Board of County Commissioners (BCC), in order of preference (ranking), up to three (3) firms deemed to be most highly qualified to perform the requested services.
- C. The (BCC) will negotiate with the most qualified firm (first ranked firm) for the proposed services at compensation which the BCC determines is fair, competitive, and reasonable for said services.
- D. Should the BCC be unable to negotiate a satisfactory contract with the firm considered to be fair, competitive and reasonable, negotiations with that firm shall be formally terminated. The County shall then undertake negotiations with the second most qualified firm. Failing accord with the second most qualified firm the Board shall terminate negotiations. The BCC representative shall then undertake negotiations with the third most qualified firm.
- E. Should the County be unable to negotiate a satisfactory contract with any of the selected firms, the Board representative shall select additional firms to continue negotiations.
- F. Evaluation Criteria: Proposals will be evaluated and ranked on the basis of the following considerations:

1. Quality of proposed program (public/private sector partnerships, expected length of training program, expected number of persons trained, expected number of persons placed, personnel qualifications, as well as provide evidence for demand or employability in the Big Bend Area of the transferable skills offered in the proposal)	50

VI. INDEMNIFICATION

The Contractor agrees to indemnify, defend and hold harmless the County, its officials, officers, employees and agents, from and against any and all claims, damages, liabilities, losses, costs, or suits of any nature whatsoever arising out of, because of, or due to any acts or omissions of the Contractor, its delegates, employees and agents, arising out of or under this Agreement, including reasonable attorney's fees. The County may, at its sole option, defend itself or require the Contractor to provide the defense. The Contractor acknowledges that ten dollars (\$10.00) of the amount paid to the Contractor is sufficient consideration for the Contractor's indemnification of the County.

VII. MINORITY/WOMEN BUSINESS ENTERPRISE AND EQUAL OPPORTUNITY POLICIES

A. VIII. INSURANCE

Proposer's attention is directed to the insurance requirements below. 5. Verification of Coverage. Contractor shall furnish the County with certificates of insurance and with original endorsements effecting coverage required by this clause.
