Independent Consultant. Have helped organizations with their diversity, journalism, public relations, and leadership programs. These have included:

July 2005-November, 2005: Special Assistant to Florida A&M University President Castell Bryant for a project addressing the academic underachievement of African American males. Included making legislative recommendations to Florida state Sen. Tony Hill for a bill he introduced into the 2006 Legislature, and making presentations in Daytona, Jacksonville and Tallahassee, assisting in organizing a town hall meeting in Tallahassee, and participating in a Tallahassee press conference.

October, 2000- October, 2001

Executive Director, Black College Communication Association Student Newspaper Institute, which was funded by a one-year Freedom Forum grant to strengthen the student newspapers at more than 20 historically black colleges and universities. Organized conferences, a job fair, awards and training activities, provided grant writing assistance and established liaisons with professional organizations such as the American Society of Newspaper Editors and with media companies including The Washington Post and Reuters.

Organized summit meetings in Washington, D.C., and New Orleans that were held in conjunction with the College Media Advisers Inc. organization. Arranged for the New York Times Company to co-sponsor the two-day summit meeting, "Training Extraordinary Journalists for Extraordinary Times" that was held in New Orleans in October 2001. There the New York Times' graphics director, recruiting editor and two reporters discussed their September 11th coverage, and its applications to journalism education. This was one of the first training presentations about September 11th coverage that any major American publication had provided. It led to the New York Times' agreeing to provide ongoing training for BCCA.

The 2000 summit meeting led to College Media Advisers' receiving a grant to establish a training collaborative relationship between mainstream college journalism programs and BCCA member programs. The program is designed to help historically black universities' student newspapers expand their coverage and increase their frequency, and it is designed to help mainstream college newspapers expand their staff and news content diversity.

May 1998-May 1999

Founding Director, Florida Institute for Leadership Excellence at Florida A&M University. The concept grew out of my three-year Kellogg Leadership Fellowship and was funded by a \$123,000 Title III federal grant that I wrote. Created a leadership center that was designed to develop a multidisciplinary cadre of visionary leaders with the ethics, insights and skills for the 21st century. The program provided honors freshmen with travel to the Dominican Republic, internships with state legislators, and a weekly series of seminars on issues that included professionalism, technology, and multicultural awareness. Participants in the program have gone on to receive a variety of honors including a Fulbright Fellowship to do malarial research in Mali.

August 1993-May 1999:

Associate professor, School of Journalism, Media and Graphic Arts, Florida A&M University, Tallahassee, Fla. Created and coordinated the Knight Scholars Leadership program, which during 1998 provided leadership training at the Academy of Leadership at the University of Maryland and at The Washington Post for honors students in the Journalism Division. Have taught courses in news and feature writing, language skills, use of information resources and a survey course introducing students to the mass media. Served as adviser to the Famuan student newspaper. Established a series of workshops in which nationally renowned professional journalists taught students about various aspects of professional development. Instrumental in The Washington Post's making a commitment to send seven staff journalists to work with Florida A&M students during spring semester, 1994. Led an effort that resulted in Florida A&M's becoming a training center for the Dow Jones Newspaper Fund's copy editing program in 1996, becoming one of only six sites in the country. Served as associate director of the program in 1996 and 1997. Under my direction, The Famuan increased its publication frequency during the 1996-1997 school year, becoming what is believed to be the most frequently published student newspaper at any historically black college. It also won numerous awards, which are detailed below.

September 1992-August 1993:

Human resources consultant, Knight Ridder Newspapers, Inc., Miami, Fla. Assisted in recruiting, training and development, especially focusing on diversity programs, for Knight Ridder's 29 newspapers and 61 business information systems. At the request of Knight Ridder CEO James K. Batten and in collaboration with the Newspaper Association of America, Florida A&M, and the Tallahassee Democrat, I established a project at Tallahassee's Rickards High School that has become a national model for attracting minority students to newspaper business careers.

September 1990-August 1992:

\* Executive Assistant to the Publisher, Detroit Free Press. Assisted Publisher Neal Shine with projects involving the community and oversaw the paper's efforts to build and train a more diverse staff. Partial list of duties included:

\* Created and coordinated "A Gift of Reading," a nationally award-winning project. The program has spread to at least 17 states and has distributed more than a million new books to disadvantaged children, and has also funded children's literacy programs.

\* Developed and ran an innovative apprenticeship program for local high school students interested in journalism (My 22 former apprentices have won more than 16 national journalism scholarships and fellowships and have gotten permanent jobs at major papers.)

\* Oversaw the paper's efforts to assist 20 Detroit public high schools journalism education programs. Assisted with local journalism camps and coordinated Free Press journalism scholarships.

\* Headed Detroit Free Press contributions committee that reviewed Detroit community grant proposals to the Knight Foundation and approved Free Press Charities grants totaling \$800,000.

\* Recruited staff

Columnist, Detroit Free Press. Wrote national award-winning "Family Ties" column, which was distributed to 350 newspapers via the Knight-Ridder Tribune News Service.

When I coordinated the contest, Florida A&M University won more Hearst awards (20) than it did during the other 20 years that the program was eligible to compete (5 awards).
