This Agreement Amendment, made and entered into this _____ day of _____ 2010, by and between LEON COUNTY, FLORIDA, a charter county and political subdivision of the State of Florida, (hereinafter the COUNTY), whose mailing address is Public Works Director, Leon County Public Works, 2280 Miccosukee Road, Tallahassee, Florida, 32308, and the OCHLOCKONEE RIVER SOIL AND WATER CONSERVATION DISTRICT, a governmental subdivision of the State of Florida organized in accordance with Chapter 582, Florida Statutes, (hereinafter the DISTRICT), c/o Chairman, Ochlockonee River Soil and Water Conservation District, Leon County Agricultural Extension Office, 615 Paul Russell Road, Tallahassee, Florida, 32301.

In consideration of services to be performed for the public benefit hereunder, the DISTRICT and the COUNTY hereby agree to amend the AGREEMENT as follows:

1. Item 10 is revised to read as follows:

10. This Agreement shall expire three hundred and sixty (360) days after the Effective Date unless extended by mutual written consent of the parties prior to the expiration date.

2. All other provisions of the AGREEMENT and associated exhibits remain in full force and effect.
