**Amendment #1 to the
Tallahassee-Leon County Animal Service Center Agreement**

This Amendment #1 to the Tallahassee-Leon County Animal Service Center Agreement dated February 26, 2003, by and between Leon County, a political subdivision of the State of Florida, hereinafter referred to as the "County" and the City of Tallahassee, a Florida Municipal Corporation, hereinafter referred to as the "City" is hereby entered into by and between said parties this _____ day of _____, 2008.

WITNESSETH

WHEREAS, the Tallahassee-Leon County Animal Service Center Agreement dated February 26, 2003, provides that the term of said Agreement may be extended for successive two-year periods by mutual written agreement of the parties; and

WHEREAS, the parties have determined it to be in the best interests of both entities to extend said Agreement;

NOW, THEREFORE, in consideration of the mutual covenants, promises, and representations set forth herein, the sufficiency of which is hereby acknowledged, the County and City do hereby agree as follows:

1. Section 1.0 Term, is hereby amended in its entirety to read as follows:

The term of the Agreement shall commence on October 1, 2008, and shall end on September 30, 2010. The term may be extended for successive two-year periods by mutual written agreement of the parties. The County shall provide written notice to the City of its desire to extend the term no later than one hundred and twenty (120) days prior to the end of the initial term or subsequent extension thereof, as applicable.

2. All other provisions, sections or requirements in the Tallahassee-Leon County Animal Service Center Agreement dated February 26, 2003, not otherwise in conflict with the provisions herein shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto, through their duly authorized representative, have executed this 1st Amendment to the Tallahassee-Leon County Animal Service Center Agreement dated February 26, 2003.
