### QUIT CLAIM DEED

**THIS QUIT CLAIM DEED**, made this \_\_\_\_\_ day of \_\_\_\_\_, 2011;  
by LEON COUNTY, FLORIDA, a charter county and political subdivision of the State of  
Florida, whose mailing address is 301 South Monroe Street, Tallahassee, Florida, 32301, Party of  
the First Part, and CORTONA HILLS, LLC, a Florida limited liability company, whose mailing  
address is 15125 North Meridian Road, Tallahassee, Florida, 32312, Party of the Second Part.

**WHEREAS**, a Conservation Easement was granted to the Party of the First Part by T &  
G Enterprises of Tallahassee, LLC, on the 24th day of March, 2006, and recorded in Official  
Record Book 4082, page 1690, of the Public Records of Leon County, Florida; and

**WHEREAS**, the Party of the Second Part is the successor to T & G Enterprises of  
Tallahassee, LLC, by virtue of that Warranty Deed dated the 30<sup>th</sup> day of May, 2007, and  
recorded in Official Record Book 3716, page 675, of the Public Records of Leon County,  
Florida; and

**WHEREAS**, the Party of the Second Part has acknowledged said Conservation Easement  
granted by T & G Enterprises of Tallahassee, LLC, recorded in Official Record Book 4082, page  
1690 and said acknowledgement is recorded as the last page of said Conservation Easement; and

**WHEREAS**, to the mutual benefit of both parties, the Party of the First Part desires to  
convey its Conservation Easement as recorded in said Official Record Book 4082, page 1690, to  
the Party of the Second Part;

**NOW, THEREFORE, THIS INDENTURE WITNESSETH**, that the Party of the First  
Part, for and in consideration of the sum of \$10.00 and other valuable consideration paid, receipt  
whereof is hereby acknowledged, does hereby remise, release, convey, and quit claim unto the  
Party of the Second Part, its successors and assigns, all right, title, interest, claim, and demand

which the Party of the First Part has in and to that Conservation Easement recorded in Official Record Book 4082, page 1690, of the Public Records of Leon County, Florida, such easement situate, lying, and being in the County of Leon, State of Florida.

**TO HAVE AND TO HOLD THE SAME**, together with all and singular appurtenances thereto belonging or in anywise incident or appertaining, and all the estate, right, title, interest, and claim whatsoever of the said Party of the First Part, in law or in equity, to the only proper use, benefit, and behoof of the Party of the Second Part, its successors and assigns, forever.
