Dear Ms. Austin:

This missive comes as a follow-up to our several recent conversations concerning the financials associated with the Leon County Indigent Burial Program.

As you know, currently the amount of money paid by your agency, per case, is a mere \$250.00. While we are committed to assisting the community in any way possible, your current allocation is far below the costs incurred by us to facilitate each burial. With gas now averaging approximately \$3.50 per gallon, we barely garner enough to cover our costs associated with personnel, alone. We often perform services at a discounted rate and, rightfully so. However, we strongly contend that Leon County must increase its allocation for its Indigent Burials. With the economy being what it currently is, we project that the community will experience a significant increase in the number of indigent requests.

We would be honored to meet and assist in putting together a platform that could mutually benefit all parties involved. Enclosed, we have a copy of our General Price List (GPL), which is given to each at-need client prior to discussing finances or payment. As you will discern from this document, what we receive from your agency is far beneath our normal service charges.

GENERAL PRICE LIST

These prices are effective as of September 1, 2010 but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Unless legal or other requirements mean you must buy any items not specifically asked for, you will be charged only for those items used. There may be extra charges for other items, such as cemetery fees and flowers.

MINIMUM SERVICES OF THE FUNERAL DIRECTOR AND STAFF

This fee for our basic services will be added to the total cost of funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains).

This fee includes the following:

Personnel are available 24 hours a day, 365 days a year to respond to initial call.

Arrangement Conference.

Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased.

Clerical assistance in the completion of various forms associated with a funeral.

Securing and recording the death certificate and disposition permit.

Also covers overhead, including facility maintenance, equipment and inventory costs, insurance and administration expenses, and governmental compliance.....\$1,125.00

PREPARATION

(Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial).

Embalming.....\$800.00

Refrigeration (It is the policy of our firm to require refrigeration of an unembalmed body. Our facility contracts its refrigeration service).....\$175.00

Other Preparation:

Dressing, casketing and/or cosmetizing of deceased.....\$75.00

Bathing and handling of deceased.....\$75.00

Special care for autopsied cases.....\$75.00

USE OF FACILITIES AND STAFF

Use of Facilities and Staff Services for visitation per day. Our services include set up of visitation area, placement of encased remains, display of floral arrangements, supervision of and attendance during the visitation).....\$275.00

Use of Facilities and Staff Services for funeral service in our chapel per day. Our services include coordinating the funeral arrangements, supervision of funeral, and staff to attend funeral ceremony..... \$350.00

Staff Services for Funeral Service in other facility. Our services include coordinating the funeral arrangements, supervision of funeral, and staff to attend funeral ceremony..... \$500.00

Use of Facilities and Staff Services for Memorial Service (without a body) at our chapel. Our services include coordinating the memorial service arrangements, supervision of the memorial service and staff to attend the service.....\$350.00

Use of Facilities and Staff Services for Memorial Service (without a body) at other chapel. Our services include coordinating the memorial service arrangements, supervision of the memorial service and staff to attend the service.....\$350.00

Equipment and Staff Services for Graveside Services. Our services include accompaniment of remains to cemetery, supervision of graveside service, and staff to attend service.....\$350.00

Transfer of deceased from place of death to mortuary (within a 50 mile radius)\$225.00
Additional distance will be charged at \$3.00 per loaded mile one-way

Funeral vehicle (e.g. Hearse) (within a 50 mile radius)\$275.00
Additional distance will be charged at \$3.00 per loaded mile one-way

Family vehicle (e.g. Limousine) (within a 50 mile radius).....\$275.00
Sedan.....\$125.00
Additional distance will be charged at \$3.00 per loaded mile one-way

Flower car (within a 50 mile radius)\$150.00
Additional distance will be charged at \$3.00 per mile per loaded mile one-way

Service vehicle (e.g. Load car) (within a 50 mile radius)\$125.00
Additional distance will be charged at \$3.00 per mile per loaded mile one-way

Transfer to or from airport (within a 50 mile radius).....\$175.00
Additional distance will be charged at \$3.00 per mile per loaded mile one-way

Transfer of deceased from mortuary to place of autopsy and return to mortuary (within a 50 mile radius).....\$175.00
Additional distance will be charged at \$3.00 per mile per loaded mile one-way

FORWARDING REMAINS TO ANOTHER FUNERAL HOME

This charge includes removal of remains, minimum service of staff, necessary authorizations, embalming, use of preparation room and local transportation (excluding shipping charges). This charge does not include visitation rites and ceremonies.....\$1,525.00

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME

This charge includes minimum services of staff, transportation from airport, and transportation of remains to cemetery or crematory. This charge does not include visitation rites and ceremonies.....\$995.00

DIRECT CREMATIONS

If you want to arrange a direct cremation, you can use an alternative container. Alternative.....\$1,295.00 to \$15,095.00
containers encase the body and can be made of materials like fiberboard or composition
materials with or without an outside covering. The containers we provide are heavy cardboard.

Crematory fee is \$265.00

Our charges for direct cremation without ceremony include:

Removal of remains, transportation to crematory and minimum services of staff

- 1. Direct cremation with container provided by the purchaser (all such containers.....\$345.00
must meet any applicable state or crematory requirements).
- 2. Direct cremation with alternative container: heavy cardboard.....\$1,450.00
- 3. Direct cremation with casket from our funeral home (in addition to cost of casket).....\$1,100.00

IMMEDIATE BURIAL

Our charges for immediate burial.....\$1,445.00 to \$15,195.00
(Without any rites or ceremonies at the funeral home, graveside or elsewhere) include:

Removal of remains, transportation to cemetery and minimum services of staff.

- 1. Immediate burial with container provided by the purchaser..... \$1,100.00
(All such containers must meet any applicable state or cemetery requirements)
- 2. Immediate burial with minimum casket.....\$2,543.00
- 3. Immediate burial with other casket selected from our facility.....\$1,100.00
(In addition to cost of casket)
