John C. Folks earned a BS degree in Forestry from the University of Florida in 1975, and a Master of Science from the University of Florida in 1981 and the State of Florida's Certificate in Supervisory Management and Certified Public Manager in 1996 from Florida State University. He has obtained other professional certifications and believes continued education is a necessity to maintain a healthy, inquisitive mind.

Mr. Folks has actively served the citizens of the State of Florida for thirty five years. He was an active participant in the Florida's educational system, earning the Teacher of the year award twice while teaching at Santa Fe Community College and Gainesville High School in Alachua County and was awarded the State Agriculture teacher of the year award in 1976. He continues to receive the true award for teaching by sharing communication with his students and sharing in their successes.

He has lead in the effort to reforest Florida through the Supervision of the State's Forestry nurseries and genetically improved seed orchards. During his tenor the State Nurseries produced over 800 million tree seedlings and wire grass plugs. He has taken an active role in the State's ground and surface water issues, pesticide use, petroleum contamination and storm water quality. He was responsible for the development and administration of the Florida Department of Agriculture's site Relocation and Inholdings Acquisition Program as part of both the Florida's Preservation 2000 and Florida Forever Programs.

He represented the Florida Department of Agriculture in the development of the Comprehensive Everglades Restoration Plan. He was responsible for the development and administration of the Florida Department of Agriculture's Lake Okeechobee Restoration - BMP Program. He developed and implemented the Florida Department of Agriculture's Agriculture non-point source BMP Research, development and performance verification program. He has served on the State's Groundwater Protection Task Force and the Governor's Commission on the Future of Florida's Environment.

He has been active in ASTM's D34 and E50 committees and actively participated in the development of standard practices E1527, E1528 and E1903. Mr. Folks' service achievements include the Davis Productivity (1991) Award, given to State employees who go above and beyond their duties in saving the State substantial expenditures through creative and unique programs and projects. He has earned two Personal Initiative Awards (1994 & 2001) from the Florida Department of Agriculture for his sustained commitment to superior work product and ability to implement, manage and deliver a diverse array of water quality programs and projects. He was awarded the Preservation Partnership Award from the Trust for Public Lands for his environmental initiatives that have enhanced the conservation and preservation of Florida's Natural Resources.

Mr. Folks has developed three "patent pending" technologies that provide simple, energy efficient, GREEN methodologies that address storm water quality and quantity, through nutrient load reduction. Mr. Folks is the founder of EnviroFolks, an environmental consulting firm that specializes in developing and applying common sense, GREEN, simple methodologies and technologies to environmental, energy, water quality/quantity issues and challenges faced by both the private and public sectors.
