Frequently Asked Questions

Distribution

1. Where will face coverings be distributed for businesses?

Face coverings will be distributed to Tallahassee-Leon County businesses at the Office of Economic Vitality (OEV), Big Bend Minority Chamber of Commerce, the Greater Tallahassee Chamber of Commerce, and the Capital City Chamber of Commerce.

2. When will the face coverings be available for distribution?

The distribution of face coverings at the Office of Economic Vitality, Big Bend Minority Chamber of Commerce, the Greater Tallahassee Chamber of Commerce, and the Capital City Chamber of Commerce will begin on Tuesday, July 7.

3. When will the distribution of face coverings end?

Face coverings will be distributed to local businesses on a first come, first serve basis while supplies last.

4. Does my business have to be a for-profit corporation in order to receive face coverings?

Any local employer, nonprofit, association, or place of worship can receive face coverings for their organization.

5. Can I still pick up face coverings for a business if I am an employee?

An employee or owner of the business can pick up face coverings for their respective workplace.

6. How many face coverings can I receive for my business?



A business with one location is eligible for up to 100 face coverings. Local businesses with multiple locations are eligible for up to 200 face coverings.

7. What do I need to pick up face coverings for my business?

Any employee or owner who picks up face coverings must provide the name of business, agree to provide these face coverings to employees and the general public, and post the Leon County [COVID-19 emergency ordinance notice](#) in a highly visible location of the business.

8. Can I come back to pick up more face coverings for my business?

At this time, businesses are eligible for one pickup, but additional offerings from the Office of Economic Vitality are expected in the future.
