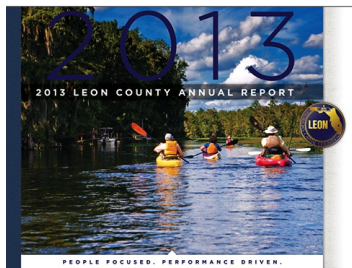

Leon County Sales Tax Extension Committee

The Leon County Sales Tax Committee signed off on their final recommendations of projects that could be funded by an extension of the current penny sales tax. The report includes a list of infrastructure improvements and economic development projects that will be taken up by the County Commission at a workshop on February 11th. The Commission will have the opportunity to make changes to the priority list before sending it to the voters for approval.

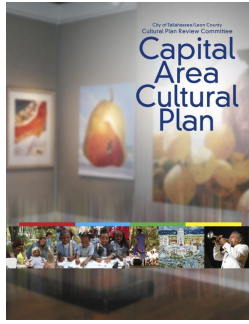


One project that I'm following with great interest is the [Lake Lafayette & St. Marks Regional Linear Park](#) - **I'm happy it's moving up the list!**

The project includes:

- A critical analysis of the floodwaters in the St. Marks and Lafayette basins which could provide flood insurance relief to property owners east of Chaires Crossroad
- Off-road trails from Upper Lake Lafayette to the St. Marks Headwaters, and trailhead improvements
- A boardwalk across the lake providing access from Apalachee Regional Park to Lower Lake Lafayette wetlands
- Construction of an additional ball field at Tom Brown Park

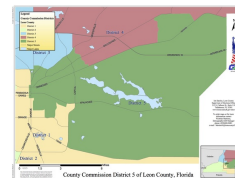
