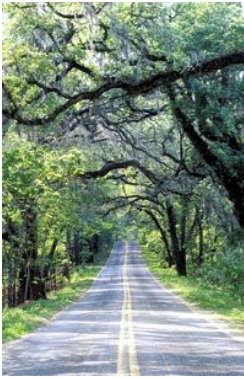

Canopy Roads Citizen Committee Review

The County Commission took action at our March 8th meeting to continue the work of the [Canopy Roads Citizen's Committee](#) (CRCC) which has been in place since 1991. The CRCC has been expanded from an 8-member to a 12-member advisory committee that will continue to make recommendations to both the city and county commissions on development decisions impacting canopy roads.

While the staff proposal would have limited the types of projects that the committee could review, the Commission voted unanimously to allow the CRCC to continue to review all development projects within the Canopy Road Protection Zone, regardless of their size. The Commission also voted unanimously to hire an in-house urban forester to assist the committee.

I felt it was important for the Commission to look at the effectiveness and efficiency of the committee, and to ensure that the Committee was meeting its goals. More than 30 citizens voiced their concerns and a common desire to keep the Canopy Roads Citizens Committee an efficient and effective group and to protect one of Leon County's most unique assets.

Thank you to all who showed up for this very important issue.

National Association of Counties (NACo) Legislative Conference

Last month I attended to the NACo Legislative Conference in Washington, D.C., where I joined more than 1,600 county leaders from across the country to discuss a wide variety of issues.



Along with educational sessions featuring members from the public, private and non-profit sectors, we met with [Congresswoman Gwen Graham](#) and [Senator Bill Nelson](#) to discuss Leon Counties legislative agenda and thank them for their past efforts. I also met with staff at the [U.S. Economic Development Administration](#) to discuss opportunities for our region.

Leon County is an active member of NACo and we received [11 NACo awards](#) in 2015 for providing innovative government programs that increase services to county residents.

Our very own County Commissioner, Bryan Desloge will be installed as the newest President of the National Association of Counties at our Annual Conference in July. As President of NACo, Commissioner Desloge will continue his advocacy on behalf of counties across the country and will be able to highlight the great work we are doing in Leon County.

Leon County Research & Development Authority (LCRDA) and Innovation Park

I was appointed to the [LCRDA Board of Governors](#) in 2010 and since that time the Board has worked to address past issues and build an organization that will play a key role in our economic future. We have home-grown assets that will help us grow and attract businesses who want to locate in a great community with two research Universities.

At Innovation Park, we are expanding resources for startups, gathering data for targeted recruiting, developing plans to improve existing buildings and creating new amenities. Also, the finalists for 2016 TechGrant Program will be announced in a few weeks and the winners will be announced at the Elevator Pitch Night event on May 19th at Goodwood Museum.

Earlier this Spring, I participated in an Editorial Review Board session with the Tallahassee Democrat. 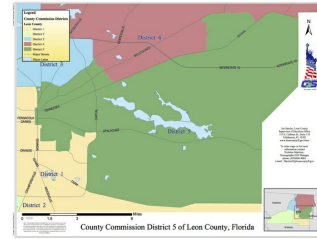
