Dear Friends:

As we continue our clean-up from Hurricane Michael, I wanted to remind residents of the ongoing efforts by our national, state and local partners and the resources currently available. Leon County homeowners continue to be eligible for temporary repairs under **Operation Blue Roof**, a program offered by the State of Florida, the Federal Emergency Management Agency, and the U.S. Army Corps of Engineers. The deadline to apply is Sunday, November 11th.

FEMA has also established a **Disaster Recovery Center** at the LeRoy Collins Leon County Main Library (200 W. Park Ave.) every day from 8 a.m. to 7 p.m. to assist those that experienced damage and loss, resulting from Hurricane Michael.

The next meeting of the County Commission will take place on Tuesday, November 20th. At this meeting we will welcome our newest member, Commissioner-Elect Rick Minor. Rick joins the Commission having been elected in August replacing outgoing District 3 Commissioner John Dailey. At this meeting, we will also reorganize the Board by electing a new Chairman and Vice Chairman for the upcoming year.

Hurricane Michael Debris Collection Schedule - UPDATE

So far, Leon County and the County's debris contractors have collected 164,685 tons of debris (more than 12,000 truck loads).

There are currently 95 debris hauling resources in the field collecting debris, and are currently working in the following areas:

Zone #1: Killearn Lakes

Zone #2: Velda Dairy Road area

Zone #3: Avondale, Timberlake

Zone #4: Lakeshore Area, Lake Jackson Heights

Zone #5: Crooked Road, Ross Road, Woodside Heights, Tower Oaks

Leon County will continue to remove debris along public and private roadways according to zones. Upon the completion of the first pass for debris collection county-wide, a second pass will begin by zone. The County's [Emergency Information Portal \(EIP\)](#) will be updated accordingly to provide the latest information on debris removal efforts.

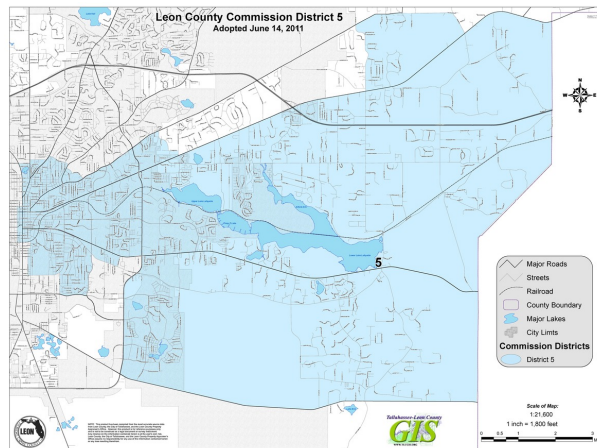
