Dear Friends:

Earlier this week we approved a new **County Budget** for Fiscal Year 2017-18. For the fifth year in a row the millage rate will remain unchanged and we continue to see property values increase. We will add an additional ambulance to the fleet and half a crew to the EMS team. We also approved funding to hire 12 new positions at the Leon County Sheriff's Office.

The Commission provided funding to raise the minimum pay to a living-wage, for Leon County employees and implemented a new paid parental leave policy for both men and women.

In addition, we set aside money from tourist development funds for various amenities, including a pavilion, at the Apalachee Regional Park in District 5.

Storm-related debris collection from Hurricane Irma continues throughout the community and will continue until all debris is picked up.


With the effects of both Hurricane Harvey and Irma felt across the Southeast, the County like other communities has struggled to get FEMA approved contractors to pick-up the debris. As a result we were forced to adjust our collection schedules over the last few weeks.

We currently have 9 trucks operating sun up to sun down and working in every zone of the County (as updated on our [Emergency Information Portal](#)).

These assets include Ashbritt (the FEMA approved sub-contractor), WastePro, other sub-contractors and all of our Public Works trucks capable of doing the work. We have an additional truck coming today from Naples and we added two (2) additional WastePro trucks this morning.


