As Leon County wraps up our response to Hurricane Michael, we are reminded that storms can impact our community at any time and we need to be prepared throughout the year.

This past weekend our community received almost eight inches of rain and some are still dealing with minor flooding issues. This weekend another two to four inches of rain is excepted so as a precaution Leon County Public Works and the City of Tallahassee will open six sandbag locations tomorrow (Thursday) at 8 a.m. (locations are also listed below).

With all of the stagnant water that could accumulate, the threat of mosquitoes and mosquito borne illness is heightened. To protect yourself and your neighbors from mosquitoes, please remember to drain any standing water to stop mosquitoes from multiplying and keep your skin covered with clothing or repellent.

Finally, the cleanup from Hurricane Michael is wrapping up in the unincorporated areas of the County. Next week, debris contractors will begin to make one final pass to collect all remaining storm related debris Please have any remaining debris placed at the curb no later than December 10th. Thank you for your patience and understanding throughout the whole process!

I also wanted you to be aware that the deadline to apply for FEMA Disaster Assistance is December 10th. You can apply by visiting the FEMA website or by calling 800-621-3362. You can also apply by visiting the Disaster Recovery Center located in Leon County at the LeRoy Collins Main Library.

Hurricane Michael Debris Collection Update

Next week debris contractors will make one final pass to collect all remaining storm debris. **Please** have any remaining debris placed at the curb no later than December 10th.

So far, Leon County and the County's debris contractors have collected 243,400 tons of debris (more than 18,000 truck loads).

Crews are currently working in the following areas, and will conclude all pickups during the week of December 10-16:

Zone #1: Meridian Road, Meridian Hills, Killearn Lakes, Louis Hill

Zone #2: Proctor Road, Crump Road, Plantation Forest, Grenville Road, Lafayette Oaks,

Miccosukee Road, Killearn Acres

Zone #3: Hidden Lakes, Twin Lakes, Tavo Trace, Woodstone, Williams Road

Zone #4: Old Bainbridge Road (North and South of 27), Lake Jackson area, Miller Landing

Road

Zone #5: Lakewood, Oak Valley, Woodside Heights, Rainbow area

Leon County & City of Tallahassee Open Sandbag Locations in Anticipation of Weekend Rain

Beginning Thursday, December 6 at 8 a.m., sandbags will be available to the public at the following Leon County locations:

Tekesta Park, at Tekesta Drive & Deer Lake Rd. in Killearn Lakes Apalachee Regional Park, 7550 Apalachee Parkway Lee Vause, 6024 Old Bainbridge Road At the intersection of Oak Ridge Road at Ranchero Road

Leon County will staff these sites and residents should bring their own shovels. Sand, bags and ties will be available for public use. Residents are asked to take no more than 15 bags so as to allow others to prepare.

The City of Tallahassee will also open the following locations:


