Leon County to Reconvene Year of the Healthy Infant

County Receives Grant to Help Close the Infant Mortality Gap


Leon County has partnered with the Capital Area Healthy Start Coalition to reconvene the "Year of the Healthy Infant" – a public forum to provide resources and information to help improve birth outcomes and identify additional opportunities to reduce the rate of black infant mortality.

The community forum will be held Saturday, March 17 from **9 a.m. to 1 p.m.** at the Florida State University Turnbull Conference Center, 555 W. Pensacola Street. The forum, which is funded through a \$130,000 Florida Department of Health / Office of Minority Health (OMH) "Closing the Gap" grant, is free and open to the public. The day's events will include an overview and analysis of the most recent infant mortality rates, a resource fair, education classes, health screenings, an update on current community efforts and more.

INTERESTED IN SERVING ON A Citizen advisory committee?

Citizen participation, by way of community input, advice, recommendations regarding matters brought before the Board of County Commissioners for approval, is important in developing Leon County's programs/policies and in providing quality public services to the community.



Currently, applications are being accepted for the appointment of six citizens to the recently established Tallahassee Sports Council. Applicants would need to demonstrate experience and interest in aspects of sports within Leon County.

Additionally, the Board is seeking applications for appointment of a citizen to the Value Adjustment Board (VAB), which settles disputes between taxpayers and the Property Appraiser; and, appointments of citizens to fill vacancies on the Canopy Roads Citizens Advisory Committee and Planning Commission. Furthermore, the terms of three members on the Contractors Licensing and Examination Board (CLEB) and three members on the Science Advisory Committee (SAC) will expire on March 31, 2012. Criteria for members of SAC and CLEB is as follows: members of SAC must be credentialed scientists; members of CLEB, except for the consumer representatives, must be licensed in Florida, actively engaged in the profession they represent on the CLEB, and be voters registered in Leon County.

Citizens can find a listing of committees on Leon County's website(www.LeonCountyFL.gov/committees)thatincludes information on committee responsibilities, member eligibility, and committee vacancies. Leon County encourages citizens to review member eligibility and, if the requirements can be met, complete and submit an application. The Citizen Committee Orientation and Training and the Committee Application can also be accessed at the County's Committee website.
