LEON COUNTY INVITES COMMUNITY TO A DAY OF REMEMBRANCE AND SERVICE 11TH ANNIVERSARY OF 9/11

Leon County Government is proud to invite the community out on Tuesday, September 11, as all come together to mark the 11th Anniversary of the 9/11 attacks. Lead community partner for this event is the law offices of Holland & Knight.

Leon County will host a service day on Tuesday, Sept. 11 at Florida State University School of Law, 425 West Jefferson Street, where volunteers will take part in a ceremony that honors all that lost their lives. Additionally, the County will recognize the first responders who risked their own lives to rescue victims, the men and women serving our nation in the military and veterans who gave so much to our country.

In keeping with the National Day of Service, volunteers will be asked to sign up to assemble military care packages for local soldiers deployed in Afghanistan. Volunteer registration and sign in begins at 10:30 a.m. and the formal ceremony begins at 11 a.m. with service projects immediately following.
