Leon County Receives National Recognition

Leon County Government received national recognition from the National Association of Counties (NACo) in several different ways last month. Leon County District 4 Commissioner Bryan Desloge was elected as 2nd Vice President of NACo during the 79th Annual Conference and Exposition. Desloge will serve as 2nd Vice President for a year, before ascending to 1st Vice President the following year and then taking over as President of the association in July 2016.



Also, Leon County was recognized with seven

Achievement Awards for successful public service programs, as well as a Digital Counties Survey Award for website transparency. NACo's awards recognize how Leon County provides the most cost-effective, high-guality service to citizens. These national awards highlight the successes of Leon County Government despite a downturn in the economy. Leon County remains committed to strengthening what works, abandoning what does not, receiving citizen feedback, leveraging partnerships and listening to changing needs.

Citizen participation, by way of community input, advice and/or recommendations regarding matters brought before the Board of County Commissioners for approval, is important in developing Leon County's programs/policies and in providing quality public services to the community.



Currently, applications are being accepted for the following Leon County Committee vacancies:

- Adjustment & Appeals Board (1 vacancy alternate member) -Responsible for determining appeals of Land Development Regulations and granting variances.
- Affordable Housing Advisory Committee (AHAC) (3 vacancies -refer to categories) - Identify incentives pertinent to affordable housing and improve affordable housing feasibility.
- Animal Shelter Advisory Board (3 vacancies citizens living in unincorporated areas) - Provide program support to Tallahassee-Leon County Animal Shelter.
- **Big Bend Health Council (1 vacancy non-governmental health care consumer representing elderly)** Provide for local representation in planning and evaluating health needs of 14-county service district.
- Educational Facilities Authority (1 vacancy) Assist institutions for higher education in construction, financing and refinancing of projects.
- Joint City/County/School Board Coordinating Committee (1 vacancy) - Fosters the coordination of comprehensive planning and school facilities planning programs.

Bulky Item and Yard Debris Pickup

As a reminder, Waste Pro offers bulky item and yard debris pickup for all subscribers in unincorporated Leon County. A bulky item is an item that is too large to fit in your garbage cart. A special pickup should be scheduled by calling (850) 606-1899.



Waste Pro has made a commitment to pick up bulky items in less than seven days. After scheduling your bulk pickup, if you notice items waiting for longer, please notify Waste Pro.

Also, Waste Pro picks up yard debris without any special notice. Debris such as grass clippings, leaves and branches will be serviced on the same day as your waste and recycling pick up. Piles no larger than six feet in length, four feet in height and four feet wide can be picked up. Larger piles can be picked up by Waste Pro, but require notification and sometimes an extra fee. Please make sure limbs are less than four inches in diameter. If you have any questions about Waste Pro service, Leon County is here to help.
