## **Emergency Detour to Aid Fort Braden Area**

In coordination with the United States Department of Agriculture Forest Service, Leon County has opened a new emergency detour route on Highway 20 West to serve the Fort Braden community. The emergency detour route ensures that citizens and first responders will have quick and secure area access if severe weather or other disasters close Highway 20 West.

Located between Joe Thomas Road West and Silver Lake Road, the emergency detour provides a more direct alternate route that is 15 miles shorter than the previous detour route.
