The Blueprint Intergovernmental Agency Board of Directors (IA Board), comprised of the Leon County Board of County Commissioners and the City of Tallahassee Commissions, has activated the COVID-19 Emergency Disaster Relief (CEDR) Grant Program.

The CEDR Grant Program dedicates \$1 million locally, offering an initial lifeline to local businesses to keep employees employed. The grant thereby supports continuity of operations as local businesses weather the economic hardships during the first critical days and weeks of the COVID-19 pandemic.

The <u>Tallahassee-Leon County Office of Economic Vitality (OEV)</u> will administer the grant program to provide initial cash flow to businesses economically impacted by COVID-19. Up to \$1 million has been allocated for the program and funds will be released on a rolling basis, beginning as soon as three to five days from now.

The distribution of the grant funds will be based on the number of employees. Businesses with one to 10 employees will be awarded \$1,500, businesses with 11 to 24 employees will be awarded \$2,500, and businesses with 25 to 50 employees will be granted \$5,000.

Thirty-five grants have already been awarded, for a total of \$86,500 so far. <u>Earley's Kitchen</u>, <u>Sweat Therapy Fitness</u>, and <u>Hair on Earth</u> are among the first Leon County businesses to receive grant funding.

Other Updates:

- The property tax deadline has been extended. The Department of Revenue extended the deadline for citizens and businesses to pay property taxes from March 31 to April 15, 2020. More <u>HERE</u>.
- The Governor has directed the State Surgeon General and Health Officer to issue a public health
 advisory to all persons over the age of 65 years old and persons with serious underlying medical
 conditions to stay home and take other measures to limit their risk of exposure to COVID-19. He
 also directed the State Surgeon General to issue a public health advisory against all social or
 recreational gatherings of 10 or more people.
- The President declared Florida a major disaster area, which grants access to certain federal programs and provides addition resources to the State.

- As a reminder, county facilities (libraries, community centers, county campgrounds, and active recreation park facilities) will remain closed through April 19.
- Tallahassee Memorial HealthCare has set up a drive-thru sample collection site at the Northwood Centre (1940 North Monroe Street) from 11 am - 6 pm, Monday - Friday. City of Tallahassee Utility Relief Program

Yesterday the City of Tallahassee has announced the Utility Relief Program, which provides City customers facing financial hardships with an option to defer payment of current monthly bill for water, sewer, electric/natural gas and other utility charges until this fall.



Participants in the Utility Relief Program can expect the carryover to be billed in installments and clearly identified as a separate line item on their future bills beginning in September 2020 through March 2021. Participating customers will also receive a reminder notice approximately two weeks prior to receiving their statement. The City will work with customers who participate on an individual basis.

Cost: Free to participate

Who May Participate: City of Tallahassee Utilities customers (residential and commercial) who can provide documentation of hardship (loss of revenue, reduced income or unemployment) due to COVID-19 during the following active program months (utility bills issued between March 12, 2020 and May 12, 2020)




Business Resource Guide



Short Time Compensation Program for Employers

The Short Time Compensation program helps employers retain their workforce in times of temporary slowdown by encouraging work sharing as an alternative to layoff.



The program permits prorated reemployment assistance benefits to employees whose work hours and earnings are reduced as part of a Short Time Compensation plan to avoid total layoff of some employees.
