We are very proud of the fact that Tallahassee and Leon County are the first local governments in the state to implement a grant program that provides initial relief funding to struggling small businesses. Our grant program, the COVID-19 Economic Disaster Relief (CEDR) Grant Program, is administered by the Office of Economic Vitality (OEV). This grant program is designed to offer a lifeline to local small businesses to sustain their viability during the application period for State and Federal relief programs and incentives.

In other words, it is a "bridge to a bridge" - to bridge the limited cash reserves of Leon County businesses as they are pro-actively taking steps to amass financing and capital from other sources (e.g. SBA, State, private).

- Qualifying businesses with 1-10 employees receive \$1,500
- Qualifying businesses with 11-24 employees receive \$2,500
- Qualifying businesses with 25-50 employees receive \$5,000


As of this writing, OEV has given out over 220 CEDR grants to local businesses, totaling nearly \$500,000.

Eligibility Requirements

- Be a for-profit corporation/business (including partnership and sole proprietor) based in Leon County (Corporate, Regional, Division, Registered Office or Franchise) and registered with the Florida Division of Corporations, with more than 1 and fewer than 50 employees.
- Demonstrate a minimum reduction of 50% in revenue as a result of COVID-19.
- Have an active Utility Account with the City of Tallahassee Utilities, Talquin Electric Cooperative
 or Progress Energy Florida in good or current status as of the date of COVID-19 Emergency
 Declaration, March 18, 2020.
- Provide proof of application for either the <u>Florida Small Business Emergency Bridge Loan</u> or the <u>U.S. SBA Disaster Loan Assistance</u> program.
- Pledge in good-faith to remain in business for at least 45 days following the receipt of CEDR funding and provide estimated average monthly operating expenses.

Recent Updates:

- Property Tax Payments are due April 15th. While tax collector offices remain closed to the
 public, customers are directed to use other convenient payment options. Property tax payments
 can be made:
 - Online at leontaxcollector.net (credit/debit cards and echecks),
 - By using the tax collector drop box located outside of each customer service center.
 - By mail (payable to Doris Maloy, Tax Collector and mailed to PO Box 1835, Tallahassee, FL 32302), or
 - For assistance or questions, please call 850-606-4700 between 8AM 1:00PM, Monday thru Friday.
- The Governor has declared:
 - A Safer-At-Home order for the following four southeast Florida counties: Miami-Dade, Broward, Palm Beach, and Monroe.
 - An executive order allowing recently retired law enforcement and healthcare personnel to return to work immediately to help with the state's coronavirus response.
- On Sunday, March 29, the White House extended social distancing guidelines until April 30. All Americans must continue to avoid nonessential travel, eating at bars and restaurants, or gathering in groups of more than 10 for at least another month.
- CDC issues Domestic Travel Advisory for New York, New Jersey, and Connecticut. Due to
 extensive community transmission of COVID -19 in the area, CDC urges residents of New York,
 New Jersey, and Connecticut to refrain from non-essential domestic travel for 14 days effective
 immediately.

For Small Businesses and their Employees: Paycheck Protection Plan (PPP)

The Coronavirus Aid, Relief, and Economic Security Act, signed into law on March 27, 2020, includes a vital new program, called the Paycheck Protection Program (PPP).

The PPP will provide those businesses with under 500 employees to receive forgivable loans for payroll and related business expenses, including rent, mortgage, utilities and health care premiums.



Certain non-profits, sole proprietors, independent contractors and self-employed individuals are eligible as well. Loans will be calculated based on a business' monthly payroll, and if used on the costs

described, will be forgiven.



While it is critical right now to stay home, practice physical distancing, wash your hands, and wipe down frequently touched surfaces/items, it's also important to stay connected with others.




TODAY is Census Day!
