Hello,

The new year is off to a busy start, and this newsletter provides information on various policy issues, projects and upcoming events in Leon County.

First, you'll find below an important section on a state grant for reimbursement of the Leon County Sheriff's Office's required support of **immigration enforcement (ICE)**. The County Commission voted on this item last Tuesday (Jan. 27th) and it's one of the most difficult votes I've had to make. Please take a look and let me know what you think.

We also have several major infrastructure projects moving forward in District 3:

\$21M for North Monroe Safety Improvements!

On December 23rd we learned that [the U.S. Department of Transportation has awarded Leon County \\$16.8 million for North Monroe!](#) This funding, combined with \$4.2 million in matching funds from Blueprint, will provide a total of **\$21 million in safety improvements** for Tallahassee's #1 gateway. Christmas came early for Leon County!

And **Leon County residents had a role in making it happen**. Almost two years ago, 1,600 people signed the '[Monroe Makeover](#)' petition to ensure that Blueprint would dedicate the required 20% match for this grant.

This funding will save lives on North Monroe, and I can't thank you enough for lending us your voice and support. Thanks also to my County Commission colleagues, Leon County Administrator Vince Long and his team, CRTPA Executive Director Greg Slay and his staff, the Directors and staff at Blueprint, the consultants at RS&H, and of course the Florida Department of Transportation and the U.S. Department of Transportation.

Other District 3 Projects

There's a lot going on in District 3. Below you'll find information about the site plan for the new **Buc-ee's**, a separate **North Monroe resurfacing project** by FDOT, upgrades to **Tharpe Street**, a FDOT resurfacing project for **Thomasville Road**, and a study on the **Orchard Pond Greenway**.

LCSO's State Grant for Reimbursing ICE support

At the January 27th County Commission meeting, my colleagues and I discussed whether to accept a **state grant** that would reimburse the Leon County Sheriff's Office (LCSO) for its required support of **federal immigration enforcement (ICE)**.

As I said at the Commission meeting, **I am appalled by what happened in Minneapolis earlier this month**. My personal opinion, based on the evidence I've seen, is that actions taken by ICE agents resulted in the needless deaths of two American citizens, and that those citizens displayed no intention of harming ICE agents in the moments before they were killed. This is NOT immigration enforcement.

I do not support the 287(g) agreement between immigration enforcement and the Leon County Sheriff's Office, but neither the County Commission nor the Sheriff has the ability to reject it. **The County Commission no authority to direct the LCSO, the state, or the federal government to curtail ICE operations here.**

According to what the LCSO's Chief Financial Officer confirmed on the record at the Commission meeting, **there will be no changes to the LCSO's required support of ICE activities, regardless of grant acceptance. No increase in ICE support, no decrease in ICE support.**

So the County Commission's vote ONLY determined whether the state -- or Leon County taxpayers -- would pay for the Sheriff's required support of ICE. That's it.

I know many people are extremely upset with the agenda item. I am, too. Before the meeting, I personally went back and forth on whether to vote YES or NO. Ultimately, though, my decision was based on the following:


- A YES vote means that the state pays for LCSO's ICE support.
- A NO vote means that Leon County taxpayers will fully pay for LCSO's ICE support.
- A YES vote does not encourage ICE to expand their presence here.
- A NO vote does not discourage ICE from expanding their presence here, and it might actually encourage them to increase their operations in Leon County.
- A YES vote is not a vote in support of ICE.
- A NO vote is not a vote against ICE.

I voted YES, because while I can't reduce ICE operations in Leon County, I could take this step so that, as a matter of principle, Leon County taxes aren't paying for it. **I believe Leon County taxpayers do not want to pay for LCSO's support of ICE, and my vote reflects that.**

Whether you agree with my position or not, I hope you'll agree that I've taken the matter very seriously and that I've tried to make the best decision possible. **If I could vote to prevent -- or even reduce -- this Administration's ICE operations in Leon County, I would do it. But that vote isn't available to the Commission.**

Thanks to everyone who has reached out on this issue. If you believe, as I do, that this Administration's ICE is a destructive force in this country and that it is violating people's Constitutional rights, you should **contact your legislative and congressional delegations** and tell them so. They need to hear from you now.

Buc-ee's Site Plan Now Available for Review



Leon County recently received the Site and Development Plan for the Tallahassee Buc-ee's. Rick will be discussing the site plan with nearby neighbors soon, and the first public meeting will be **February 4, 2026**, at **1:30 PM** at the **Renaissance Center (435 North Macomb Street) on the Second Floor** in the main conference room. The public is welcome to attend, and Rick plans to be there as well.

Monroe Street Resurfacing Public Meeting





Black History Month




Black History Month is celebrated in February and recognizes the contributions, triumphs, and achievements of Black Americans in history, culture, and society.

Public Meeting: NW Connector - Tharpe Street Project Development and Environment (PD&E) Study



The Blueprint Intergovernmental Agency will hold a public information meeting concerning the above referenced project on **Thursday, February 12, 2026**, from **5:30 pm to 6:30 pm (EST)** at **Abundant Life and Restoration Ministries (ALARM) International Church, 2532 W Tharpe Street, Tallahassee, Florida 32301**.

The purpose of the project is to improve multimodal, pedestrian safety, and traffic operations by **adding sidewalks and intersection improvements** along the corridor as well as associated stormwater infrastructure. The total distance of this study is approximately 2.6 miles.

Maps, drawings and other information will be on display at the meeting. Representatives will be available to discuss proposed improvements, answer questions, and receive comments. Additional project information is available [here](#).

Prior to the event, Rick was pleased to join Vince and other County commissioners and County leaders, along with World Athletics President Sebastian Coe and five-time world cross country champion Paul Tergat, for the official 2026 World Athletics Cross Country Championships press conference at Apalachee Regional Park (ARP).

More than 15 years ago, Leon County began transforming ARP from an inactive landfill into what is now one of the most respected and talked-about cross country venues in the world. That vision has been recognized on the global stage. **World Athletics even declared ARP the best cross country course in the world and named Leon County the cross country capital of the world!**

The event was one for the books and we are so proud of and grateful to everyone who was a part of it.

Lake Jackson Dry Down

Amtrak Update



Recently, Rick attended (virtually) the Southern Rail Commission's board meeting, where they announced the ridership numbers for the "Mardi Gras" route, which runs twice daily between New Orleans and Mobile. Officials are calling this **new passenger rail service** "one of the most successful service launches in Amtrak's history", with 46,000 riders in just the past four months.

Why is this important to Leon County and North Florida? **The new route's level of ridership — twice what was expected — bolsters our argument for restoring passenger rail in North Florida.** As shown in this [NBC15 news segment](#), passenger rail service improves connectivity between communities and helps local businesses.

Rick continues to champion Florida joining the Southern Rail Commission and is advocating for it during this legislative session, and we're further along than ever before. Currently there are standalone Southern Rail Commission membership bills in the House and Senate, and there is SRC language in the Senate version of the Transportation bill.



FDOT Conducting Design Phase for SR 61 (Thomasville Rd) Resurfacing Improvements

The Florida Department of Transportation (FDOT) has an upcoming Thomasville Road (SR 61) resurfacing project which will extend north of 9th Avenue to south of Maclay Road. The project is currently in the Phase II stage (60% of design), with construction scheduled for fiscal year 2027. Stay tuned for additional updates once design has been completed.

Arbor Day Celebration



Rick and his daughter recently joined nearly 100 community volunteers and staff to celebrate **Florida Arbor Day** at St. Marks Headwaters Buck Lake Trailhead. The group successfully planted more than 200 native trees at the annual Arbor Day Tree Planting event hosted by Leon County Government.

Each year, this event supports and strengthens the hundreds of native and migratory species that call Leon County home, while also contributing to the community's beautification and the overall improvement of the environment. Native trees, such as Shumard oak, Live oak, Willow oak, Crabapple, and Beautyberry, were among the variety of species planted, contributing to the community's aesthetic appeal and environmental well-being.

The Arbor Day Tree Planting event is one of the many ways the County and City protect and preserve our local ecosystem. Another initiative, the [County's Adopt-a-Tree Program](#), has led to the planting of thousands of native trees in our community by providing free trees to citizens.

Florida AI Classroom of the Future Event



Rick recently participated in a Fireside Chat at the **Florida AI Classroom of the Future Event**. This was a premier two-day event designed to showcase the transformative impact of artificial intelligence in learning.

In partnership with Tallahassee State College, the Florida K-12 AI Education Task Force, the University of Florida, and the Florida School Board Association, this event brought together key stakeholders, including K-college educators, technology leaders, and policymakers, to explore the future of AI-powered education.

The panel that Rick sat on was called *Future-Ready: How Sector Leaders Are Uniting to Shape a Bold Municipal Vision in the Age of AI*. That panel brought together leaders from government, business, education, and technology to reimagine what a forward-thinking, AI-enabled community can look like. Panelists highlighted how cross-sector collaboration is shaping Tallahassee and Leon County's municipal vision, driving innovation, and preparing the community for an AI-driven future. They discussed strategies for economic development, workforce readiness, and public engagement, explore how AI is transforming local services and industries.

During the panel, Rick spoke about the importance of cultivating a community that is informed, prepared, and empowered. One exciting step toward that goal is a new AI / Digital Literacy Training program he's been developing with private sector and higher education partners. **This training will help Leon County residents avoid scams, phishing, and ID theft, and will provide tools for using AI safely and effectively.** The training is scheduled for rollout this spring and will be open to all—watch this newsletter and Leon County communications for registration information.
