

The Latest from Your District 5 Office

Dear Friend.

Our community is in mourning for the two lives lost, the six people injured, and the many whose sense of safety was shattered during the mass shooting on campus last week. From the moment the shooting started, our community stepped up - FSUPD neutralized the threat within minutes, EMS and Fire enacted mass casualty plans, community partners expedited resources to support anyone needing help after the tragedy, and students are speaking up to reduce the chances of this happening again.

My heart goes out to the families of Robert Morales and Tiru Chabba, who lost someone special on Thursday. My heart also goes out to the five people injured and the many people who had to live through a terrifying shooting, not knowing if they would live that day, and to their families and friends who waited to hear from them with the same fear. Their lives are forever changed by this tragedy in a way no one should have to experience.

Every person in Tallahassee is affected by the tragedy in some way. No one needs to go through this alone. We have lots of resources for you to get help. You can call 2-1-124/7 for free and confidential support. You can call or text the National Disaster Distress Helpline at 1-800-985-5990. Everytown for Gun Safety is providing this list of many resources.

I thank our local law enforcement for their fast and professional response. The FSU Police Department responded and eliminated the threat within minutes, with assistance from the Tallahassee Police Department, Leon County Sheriff's Office, and other law enforcement agencies. They train for this to prevent what was already an absolute tragedy from becoming much worse. Following the shooting, the FBI created an online tip submission portal at www.fbi.gov/fsushooting. They ask anyone with video, photos, or audio from the Student Union area to upload it to assist investigators.

I am proud of the Leon County team that responded immediately during the shooting. Leon County EMS affected our mass casualty response protocol and supported the unified command at the scene. The Leon County Emergency Operations Center was activated to help law enforcement and healthcare partners, and County Emergency Management Liaisons embedded with FSU to streamline coordination.

Your Leon County Commission will continue to do everything in our power to eliminate this senseless gun violence, especially at schools where students deserve to learn in a safe environment. In 2018, we adopted the "Gun Show Loophole" Ordinance, requiring a three-day waiting period and a national criminal history background check for all firearm transactions conducted on publicly accessible property in Leon County. Also, as part of our legislative priorities, we continue to support local universities and colleges in opposing concealed weapons on campus, as we have done since 2015. While the State of Florida has put significant limits on what local governments can do about gun safety, we continue to do everything in our power to eliminate mass shootings like this.

Many students at FSU and others are speaking up to officials, particularly at the state level, demanding action to make our schools safer. If you want to see what they are asking for, you can visit their websites:





In our effort to keep you informed about the decisions we make on various issues, I am posting some of the key votes from our April 8, 2025, County Commission Meeting.






Shelter Pet of the Month - Delilah

Shared Decisions with the City Commission: I vote on overarching goals, objectives, and policies that guide development across both the city and unincorporated areas.


Unincorporated Area Land Use Changes: I vote on land use and zoning changes for properties in unincorporated Leon County.

RaceTrac Gas Station Intersection of Mahan Dr. & Vineland Dr.



A RaceTrac gas station is proposed for the northeast corner of the intersection of Mahan Drive and Vineland Drive. The gas station would include a 6,008 SF convenience store, 16 fueling positions (8 pumps), and 4 semi-truck fueling positions. On February 28, 2025, 37 direct mail notices were sent to property owners within 600 feet of the site as well as, Homeowners' and Property Owners' Associations within one mile.

The first public meeting, an Application Review Meeting (ARM), was held on March 12, 2025. At the meeting County staff identified a number of deficiencies in the site and development plan and recommended a second public ARM meeting which will be held on April 30, 2025, at 1:30 p.m (2nd Floor Conf. Rm. - 435 N. Macomb St.).

Washington Square Update



At our April 8th County Commission meeting I received unanimous support from my fellow Commissioners to have our staff bring us back information on a **timeline and costs that it will take to repair the County roads** (Calhoun & Gadsden Street) surrounding the failed Washington Square project. A part of my request also included all legal options we can pursue to collect the money we now have to spend to fix the surrounding roads.

This city-approved project came to a abrupt halt in 2019 and the site remains dormant, blocking sidewalks and right-of-way. Based on the updates provided at our meeting, the developer has no remaining assets and is facing over \$400,000 in accumulated fines and violations.
