### **Celebrating Our Achievements**

# **Shelter Adoption Information**

# **Upcoming Affordable Housing Vote Tuesday, January 28, 2025**

Last month I told you about the unanimous vote of the County Commission to have staff analysize of a proposal developed by the <u>Capital Area Justice Ministry</u> (CAJM). The proposal would set aside 20% of the county's annual Blueprint surcharge revenues, beginning in 2026, to fund an Affordable Rental Housing Land Acquisition and Leaseback Program modeled on the <u>Penny for Pinellas Land Assembly Fund</u>.

We expect this information to return to the Commission for a vote at our January 28, 2025 meeting. If approved, this proposal would set aside nearly \$1.3 million each year for affordable rental housing projects that include rental units for extremely low—and very low-income families.

For years, CAJM has developed well-researched proposals to increase the stock of affordable rental housing for low-income and very low-income families. They have advocated at the City of Tallahassee and the Blueprint Intergovernmental Agency and are now working on the Leon County Commission. Will your Leon County Commission be the first to say YES to doing something to stem the worsening affordable housing crisis?

#### **How it Works:**

The plan that CAJM is proposing allows the Leon County Housing Finance Authority (HFA) to review developer applications and obtain appraisals for the land proposed for the project. If approved, the HFA commits to purchasing the land and then leasing it back to the developer for 99 years for an annual fee in addition to the property taxes they would pay.

In exchange, the developer would agree to set aside a specified percentage of units for renters with extremely low and very low incomes. The purchase-leaseback arrangement reduces the developer's upfront capital costs by the amount of the cost of the land. This reduces the debt the developer must incur to begin the project and frees up money to be devoted to other project capital costs.

## **Year in Review**

- Comcast began adding 300 miles of fiber in Chaires, the eastern portion of District 5. When completed in in 2026, 3000 households will get connected to high-speed internet through this project.
- Phase 2 (Pontiac Dr. to Diamond St.) of the Magnolia Drive Multi-Use Trail in District 5 broke ground in May 2024. The anticipated completion date of this phase is Fall 2025.
- Improved the County's Parental Leave Policy to provide eight (8) weeks of paid leave at 100% of the employee's rate of pay following the birth or adoption of a child.

- Approved funding for a third H.O.S.T. Sheriff's Deputy to reach out to the unhoused to help them find housing.
- Added an individual who currently benefits from a rental housing assistance program, has benefited from an
  affordable homeownership program, or experienced an eviction within the last 10 years to the Affordable
  Housing Advisory Committee.
- Directed staff to bring back an agenda item to consider an ordinance restricting sales of certain animals at pet stores in Leon County to reduce overpopulation from puppy mill breeders.
- Approved an agreement with Florida Gulf & Atlantic Railroad to install new crossing surfaces and pavement markings at seven railroad crossings in Leon County.
- Directed staff to collaborate with CAJM to prepare an agenda item with a proposal amending the 5-year capital
  improvement budget to set aside 20% of the county's annual Blueprint surcharge revenues, beginning in 2026, for
  the duration of Blueprint 2020, to fund an Affordable Rental Housing Land Acquisition and Leaseback Program
  modeled on the Penny for Pinellas Land Assembly Fund.
- Directed staff to prepare an agenda item identifying new actionable ways to prevent pedestrian-related severe injuries and fatalities in all of Leon County, incorporating lessons from successful example governments.
- Approved the 2024 Annual Affordable Housing Advisory Committee Report of Recommendations, including a SEER energy-efficiency recommendation made by ReThink Energy., which will result in lower monthly utility bill amounts for the affected low-income households.
- Directed staff to conduct a traffic and safety study for pedestrians and vehicles from the intersection of Apalachee Parkway and Capital Circle SE eastward for five miles just beyond the Apalachee Regional Park.

## **Food Distributions During the Holidays**
