# June is the start of the 2023 Hurricane Season

June 1 marks the start of Hurricane Season, and Leon County Government encourages residents to prepare themselves, their homes, and their neighborhoods for disasters.

The National Oceanic and Atmospheric Administration (NOAA) has predicted that the 2023 Hurricane Season could see an estimated 14 named storms, seven hurricanes, and three major hurricanes. This makes it all the more important for residents to be ready.

Leon County urges all residents to take the necessary steps to prepare for the 2023 Atlantic Hurricane Season. This includes creating an emergency kit, developing a family communication plan, and staying informed about the latest developments and updates through the County's Emergency Information Portal at **LeonCountyFL.gov/ei**.

# Highlights of Leon County's new WastePro Contract

Leon County will enter in to a new contract with WastePro on October 1, 2023. There are many **new** requirements in the contract, including:

 Bulky pick-ups must occur within 3 days of normal service (no call-in's required for bulky)

Litter/spills must be cleaned up within
24 hours.

Local call centers must be staffed with local people

Broken equipment must be reported to
Leon County within one hour and backup
equipment on the road within 2 hours.

Customer voicemails must be returned within one hour. After hours voicemails returned within one day.

Customer complaints before noon must
be resolved on same day. Complaints
after noon resolved next day.

□ Trash carts must be left upright with lids closed.

Door-tag notifications must be left
