- 5. **Evaluation Parameters:** The HFA action on responses to the Request For Qualification normally will be taken within thirty (60) days after the submission deadline, however, no guarantee or representation is made herein as to time between submission of the responses to the Request For Qualification and subsequent HFA action.
- 6. Reserved Rights: The HFA reserves the right to accept or reject and/or all responses to the Request for Qualification, to waive irregularities and technicalities, and to request resubmission. There is no obligation on the part of the HFA to award the contract to the Respondent with the lowest cost, and the HFA reserve the right to award the contract to a responsible respondent submitting a responsive Request For Qualification, and the resulting negotiated agreement that is in the best interest of the HFA, and its decision shall be final.

- 3. Location of Branches in Leon County (including within the City of Tallahassee), including capacity for after-hours deposits.
- 4. Debit card availability and cost, if any.
- 5. Information on the parameters of the checking account, including internet banking options (wires, ACH, check inquiry, stop payments, and other items)
- 6. Check Imaging capacity, with minimum 18 month history capability
- 7. Monthly fee information, and any transaction specific fees
