Leon County Newly Assigned Street Name Notifications

Located in the new Avery Park Subdivision – In Township and Section 11-24, 1N 1E. The new street names of *Avery Park Dr.*, with an address range of 811-868 and *Sydney Dr.*, with an address range of 700-751. Both streets are public and paved.


City of Tallahassee Street Renaming Notification




